DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This little house in two parts faces north, the roof ridgelines running east-west. Each part has 3 bays by 2, and a large chimney rises from heating fireplaces in either outside end wall.

The larger stone section, 2 stories high looks to the west. Windows downstairs have 9 lights over 6, upstairs 6 over 6. Shutters are louvered, the cornice plain. A small portico shelters doors at either end of the central hall.

A new frame section to the east has a gambrel roof with peaked dormers. Windows downstairs have 8 lights over 12, upstairs 9 lights over 6.
