

**Esdraelon Lodge #176**  
**HA 944**

This two-story utilitarian building is located on the west side of Main Street in the village of Cardiff. A handsome circa 1910 brick structure, it was built for Esdraelon Lodge #176, Ancient Free and Accepted Masons and is still used today as a meeting hall for the Masons, which meets twice monthly, and for the women's group, the Eastern Star. The building's Greek Revival gable-front is appropriate for its use as a Masonic hall. An imposing structure, its subtle details, such as its brick relieving arches, wrap around veranda-style porch, lend to the building's breadth. Remnant Victorian elements, the cut-out balustrade and brackets, scroll-shaped brackets, and fish scale siding, are incorporated. The building's slate roof and coursed slate foundation are distinctive to this historically famous slate quarrying region.

This two-story utilitarian building is located on the west side of Main Street in the village of Cardiff. Unique to the town, the building is an all brick structure as indicated by the relieving arches over all openings. Built as a Masonic Hall, the building's Greek Revival gable-front with and narrow wrap-around porch rest directly on Main Street. The symmetrical building is four bays by five on the first-story and three bays by four on the second with two small utility projections mirroring each other on the first-story westbays of the north and south walls. An internal chimney rises from the gable peak towards the west end of the ridge. The roof is covered by a broad expanse of slate shingles and the foundation is of coursed slate, as common in this slate region.

The first-story accommodates two identical side-by-side apartments running the length of the building. A marble cornerstone is in place at the front corner of the north side apartment. The apartments' two entrances are side-by-side simple doors with transoms and relieving arches in the lower story front middle bays. Additional access is achieved through the north and south sides at the middle bay. The west bays on either side have small projections, as mentioned previously. All other bays on the first-story have 2/2 sash windows with thick sills, relieving arches, and working shutters. A veranda-style porch wraps around the front and sides of the structure. The ground falls away from the front of the porch where it meets Main Street leaving the north and south sides supported by straight posts which match those of the porch, creating a two-tiered effect and exposing the beautiful slate foundation. This southern veranda effect is enhanced by a cut-out balustrade and brackets and stairs at the west end of both sides which follow the utility projection lines.

The second story is said to be one large meeting hall for the Ancient Free and Accepted Masons. The main facade and north and south sides have windows with relieving arches and closed shutters articulating each of the bays, three on the main facade and four each on the sides. Above the second story, the gable is made decorative with fish scale siding and supporting scroll-shaped brackets for the roof overhang.

The building's Greek Revival gable-front is appropriate for its use as a Masonic hall. An imposing structure, its subtle details, such as its brick relieving arches, wrap around veranda-style porch, lend to the building's breadth. Remnant Victorian elements, the cut-out balustrade and brackets, scroll-shaped brackets, and fish scale siding, are incorporated. The building's slate roof and coursed slate foundation are distinctive to this historically famous slate quarrying region.

Originally, the lot on which this hall is built was one of several parcels in the immediate area owned by Richard Roberts. Richard Roberts, co-founder of Roberts and Wilhelm which evolved to Richard Roberts and Son, operated the metal foundry and machine shop on the land below and adjoining this Main Street lot. He sold the town lot to the Ancient Free and Accepted Masons in 1904 for \$250.00. The location of the earlier meeting hall was nearby at the southeast corner of Church and Main Streets and is now a vacant lot.

Originally owned by Thomas Hawkins (farmer) in a patented land grant known as "Hawkins Chance", this land was part of the tract sold by the Hawkins family to Rowland Parry, a Welsh quarry owner who operated one of the first prominent commercial quarries in the area. It was Parry who exhibited Peach Bottom slate in the London Crystal Palace exposition in 1850, winning it international recognition as the world's finest slate. "Hawkins Chance" was divided and sold in pieces, passing mostly through the hands of Parry's relatives and countrymen in various forms. The parcel of 17 acres that created this lot was sold to the South Delta Land Company in 1896 through an Equity Case on behalf of Parry's great niece. As with Esdraelon Lodge #176, most of the structures at the north end of Cardiff were built around the turn of the century, after this subdivision took place.




