DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This frame house, Victorian, covered with clapboard and scalloped shingles, is basically square but with an open plan inside, taking advantage of early central heating throughout the house and opening out to porches on three sides. Asymmetrical placement of first floor windows agrees with the interior plan. On the front of the house a large dormer roof crosses the roof ridge line over windows on two floors. Decorative elements are restrained, and include multiple small window panes in top sashes, turned porch posts, and patterned shingles.
