

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

A log cabin protected from the weather by a tin roof, clapboard outside, plaster and lath inside, preliminary investigation found it to be in excellent condition.

Owned now by Jones-Plymouth Co., it was offered to the Maryland Historical Society as a gift. They refused it, having found a mover who could relocate it on their Bel Air site for a nominal fee.
