DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is located on the south side of Prospect Mill Road where it ends at Fountain Green. It is a 1-1/2 story log house that originally had a one room down one up plan. Mr. Mennick aged 72, grew up here as part of a family of eight and recalls that the upper room was partitioned to divide the boys and girls (he recalls three beds) and that his father built the single story lean-to kitchen.

Demolition was in progress at the time of recording enabling the following observations.

The original building was 18'6" wide and 16' deep. Its overall plan has changed twice. While in its final stage it faces the crossroads (north west) and had a 10' kitchen wing to the south and while the north facade was probably originally the main facade at one point there was a gable-end entrance on the west. It may have originally been a window that was opened up into a door and then reduced to a window again.

There were porches in both the east end and north side. The north side has a centrally located entrance with 6/6 windows with bubbled glass on either side. An entrance corresponds on the south side where there may also have been a window in the west bay. The east end is blind except for a window in the far north bay. A set of windows occupies the south east corner.

It would appear that the logs were never exposed to the weather. plain clapboards with cut nails survive in the north facade. The logs are v-notched, are 6" in thickness and 8-10" in height. They appear to be chestnut hewn on two sides only. 2-3" thick hewn boards 3-4' long are used for chinking along with mortar.

The roof and gables are framed up with vertically mechanically sawn rafters and studs. The rafters are mitered at the ridge and were originally left exposed and white-washed.

There is no cellar; the sill logs rest on a 10" high rubble foundation. The lean-to was already torn down Sept. 9, 1980 exposing the method of its support. The addition butted up against the south wall of the log house and rested on locust piers approximately 20" long and 8" in diameter. They were driven at least a foot into the ground with 6-8" exposed. Only two were extant at the time of recording but depressions suggested that there may have been as many as a dozen with 4' centers.

Mr. Minnick relates that his father John Minnick ("Pap") was a farmer who used to live in the log house further north on Fountain Green Road. He moved his family here c. 67 years ago. A colored man named Wes Bowen had lived here before them. Mr. Bowen had hung himself and Mr. Minnick recalls Pap pointing to the eaves of the south west corner (and where there used to be a window) and saying that thats where he had done it.

Mr. Minnick was 7 years old when they moved here. He is certain that his father added the kitchen recalling a large "hole with rocks in it being just behind the house" at first.

There was a stable about 25 yds. south of the house although "in them days it was rough" and Pap walked to Bel Air where he took work as a carpenter.

There was a smokehouse east of the dwelling. The family kept hogs and chickens and grew a garden because "you had to". The privy occupied various places behind the house and to the east. A large hole was dug and the privy placed over it. This process took place from time to time as the hole was filled up covered and a new one dug. The same privy was moved over it. It was not necessary as often as once a year but was necessary "from time to time."

Subsequently, the farm passed to his son John Moore and then James Moore, a member of the Maryland Legislature.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This cross-breed house is located on the southeast corner of the intersection of Fountain Green & Prospect Mill Roads. It represents a curious mixture of elements, retaining cryptic clues to an earlier visage. One story with a gable roof and a brick chimney in the east end, its front facade and part of the east end are board and batten, while the others have various other 20th century veneers. On the rear are two additions, a shed-roofed one apparently older than the flat-roofed adjacent one that extends beyond the east end of the house. Set on a low stone foundation, the fenestration is varied. The first story windows have 6/6 sash, while the window in the west gable has 9/6 sash, and the two gable windows in the east end have four lights. (One now has only a single light).

The north side has a central door flanked by a window on both sides. The west end has one window in each story, while the east end has a window in the first story north bay and two gable windows.

STATEMENT OF SIGNIFICANCE

This house was on the Moores estate--and probably served as a tenant house--until 1915, when it was sold on a parcel of 178 acres to James and Elizabeth Neikirk.¹

Purchased by James Moores in 1773, the land already had on it a gristmill, dam, dwelling house, stable, barn, and sawmill. James Moores was a tanner and used the sawmill for cutting and removing bark from oak trees to use in vats for tanning leather. By the time of his death in 1791, his farm comprised 750 acres, including part of the tract called "South Hampton" (patented to Henry Wriothsley in 1699). The farm passed to John Moores, who married Mary Scott and owned it until his death in 1823, and then to his son, James Moores, who was a member of the Maryland Legislature. The latter never married, so his nephew, James Moores, son of Aquilla and Aphia Moores, inherited the farm in 1853. He too never married, and when he died in 1873 his brother, John Moores took over the estate.

By 1911, when John Moores died, the "home farm" comprised 390 acres. The north half with the dwelling and farm buildings was willed to his daughter, Mary. The south half (approximately 186 acres) on which this particular house stands, went to his son George G. Moores. In 1914, he exchanged his share (except for an 8 acre lot; see Moores-Crouse House, HA-) with his brother, Edward P. Moores, who then sold it to James Neikirk.

The 1858 Herrick's Map shows that J. Markley occupied a house near this location. The 1878 Martenet's Map lists H. Haughty or S. Chauncey (colored) as the occupant.




