This small house really belongs in the small country town that once was Aberdeen. Out of place on US 46, it seems ~~then~~ impervious to change in spite of the thunderous traffic at its door and the New-York to Washington fast passenger train and freight at its back yard. The abnormally high demand for medium to low-cost housing is probably responsible for its survival here.

Typical of dozens of small frame houses on newer streets in this town, with slight variations on the theme.




