DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

These two board and batten buildings are at 13-19 E. Ellendale in the Town of Bel Air, Harford County, Maryland. They are stained red.

Building #1 is two and a half stories tall with a gable roof and two shed-roofed additions on the east side. The front is vaguely three bay with a pair of glass and frame doors in the middle of the front (north) elevation. A tall plain chimney stack rises toward the eaves on the north end of the west elevation. A large 12 pane window lights the second story middle bay, flanked at some distance by a 6 pane window. The rear (south) elevation has a pair of sliding barn doors on the first story.

Inside, the ground floor is one large room with ancient plush theater seats around two sides of an auction platform. The second story has four small rooms in front (north) and one large room in the rear.

Building #2 is a long, shed-roofed building with a garage door in front and sliding barn doors in the rear. It is one large room inside.

STATEMENT OF SIGNIFICANCE

These two red stained board and batten buildings are unique in Bel Air: the only commercial stable buildings remaining. As they near the century mark they are healthy and useful as the home of Bel Air's Acution Gallery. They have an austere and unadorned geometric beauty. The railroad and the railroad station they were built to serve have gone with society's changed transportation needs. The horses and buggies that they once sheltered are gone, too, in a previous transportation change, but these large, functional buildings remain as the very home of changing needs, for the cast off items of one family or one generation are brought here to be sold to new families in the weekly auction.

Henry B. Bruns built these stables and the store to the west in 1887 on land purchased from Charles L. Dallam (58/195), 59/423). The situation was very close to the new railroad. Bruns called them an "exchange stables" which suggests a "rent-a-buggy" service - you could leave a rented rig there and it would find its way back to where you rented it.

Brun's heirs sold the property to David Crystal of Baltimore City in 1920 for \$2000 (17/75). Crystal mortgaged the property that year and defaulted on the mortgage in 1925. The Permanent Building Association of Harford County, the lending institution, bought the property at auction in 1925 for \$1500 (195/231). Crystal seems to have bet wrong on the survival of horse-drawn transportation.

The next week the McComas Brothers bought the property (195/242). The 1930 Sanborn Map shows the larger building was used for equipment and truck parking and the smaller building as a beverage warehouse. After the deaths of Emory and Stanley McComas, the property was conveyed to William McComas, one of Stanley's sons (1941, 267/1). In 1974 McComas conveyed it to his wife, Lee Anna (951/1002), the present owner. William McComas is now dead.






