This is one of the latest houses built in the Victorian manner with a front gable. It is an excellent example of the style except for the fact that the entrance is in the middle bay rather than to one side as was more common. This does not mean a center hall plan. The door opens straight into the parlor. The house was beautifully enlarged in the late 1960's with the addition of a two bay, one and a half story brick wing to the north and a three story two bay brick section to the back of the ell.

The law firm of Connor and Carr has its offices on the first floor, and there is an apartment on the second floor.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This three bay, two and a half story shiplap house with brick additions is at 9 S. Hickory in the Town of Bel Air, Harford County, Maryland. It is an excellent example of how a beloved (or useful) style lingers in the country districts. With its steep pitched slate roof, its front gable with round-headed 2/2 window, its hipped roof porch on stock turned posts, its 2/2 windows except for the long 2/4 in front in the first story, and its wooden louvered shutters, it is exactly like houses built on Broadway in the late 1870's, but this particular house was built after 1902.

Two common bond brick portions, a two bay single story wing to the south and a 3 story, 2 bay ell in back (east) were added by Mr. Sparr after he bought the property in 1969. The wing has a steeply pitched gable roof with a set-back in the north ends to allow light into second story windows in the main block. Windows in the wing are 6/6 and there is an entrance in the north bay of the front (west) elevation. The ell in back is more elaborate. Because of the slope of the lot, this section rises three stories and has a terrace level office. Major windows are 6/6, but there are a pair of french windows on the south elevation in the first story as well as a pair of blind archs, one on the first and one on the second story in the east bay of the south elevation. The one in the first floor accommodates an air conditioner.

Besides the door in the south wing, there are three entrances. One is in the north bay of the terrace office. The major entrance is in the center bay of the first floor front (west) elevation. It has the common 2 pane transom over a single pane over three panel door. The entrance to the second story apartment is in the west bay of the back building. A wooden staircase rises parallel to the wall plane to a stoop. The door is four panes over panel. This entrance was added after 1969 because what had been the parlor was used by Mr. Sparr as an office. This door became the entrance to the residential portion of the building. A door to the east of the staircase gave on to the back part of the house. This door is no longer used.

The interior of the main block has reeded door and window surrounds with carved corner blocks in a 'door-bell' design.

The west chamber on the first floor, once the parlor, is now the reception room for the law firm of Connor and Carr. To the east is a hall opening into the brick wing on the south, a small office on the north, and the bathroom on the east. The small north office opens into another office which was once the hall leading to the staircase. The basement stairs (under the main staircase) are in the west end of this room. A door to the east leads to Commissioner Carr's office in the brick ell.

The staircase to the second story is now enclosed. It has the slender balusters and slender turned newel of the Colonial Revival. They date to the post-1969 renovations.

The second story apartment has three rooms, a bath, and a storage room in the main block, and a bedroom and bath in the brick ell.

One large finished room occupies the attic level.

STATEMENT OF SIGNIFICANCE

This house is an attractive example both of modern additions to an older house, and of adaptive re-use. The brick wings were added by builder Leroy Sparr when he remodeled the house to be his residence c. 1969. Today the ground floor is the office of the law firm of Connor & Carr. Partner William Carr is a Bel Air Town Commissioner and chairman of the Harford County Committee of the Maryland Historical Trust. Mr. Connor died in 1979.

The house was probably built around 1903 by Charles Robie Grafton. He bought a 130' x 168' lot from Charles L. Dallam in 1902 for \$400 (104/20). He sold 80' x 165' to Joseph Deckman in 1903 (109/275) suggesting he was raising money to build the house. He was single at the time. When he sold this lot to Laura V. Hollis in 1906, he was married. She paid \$1650 for it (117/246). Did he build this small house and live in it until he married? Or did he build it for his bride? At any rate the house was there when he sold the lot to Hollis. She sold the property to Charles O. Lee in 1914 for \$2600 (145/227). She was living in Baltimore City at the time.

Charles and Rosa Lee spent the rest of their lives in the house. Mr. Lee died in 1958, and Mrs. Lee died in 1969. Her executor, Bertram B. Coale, sold it to Leroy Sparr in 1969 for \$17,000 (825/136). Sparr sold it to William K. Connor and his wife Nancy in 1974 (956/930), and it became the offices of Connor and Carr. It has an apartment upstairs and a "terrace level" office in the rear is rented to an insurance agent.




