The property is described in the Maryland Historical Trust Inventory Form For State Historic Sites Survey prepared by Natalie Shivers, Historic Site Surveyor with Harford County Historical District Commission, in March 1980. Following is a brief summary of that property description, as modified by site observations made January 17, 2003.

The house and evidence of surrounding outbuildings are in ruins, and the site is completely overgrown.

From the description, the house is a two story, gabled roofed (east to west), finished with stucco and rubble stone. The house is two bays wide and two bays deep with an interior chimney on the west side and an entrance on the north side. Also on the property are the ruins of four wood framed outbuildings. At the time of the visit, the wood members and roof have deteriorated and were not visible. The remains of the main building were also covered with vegetation. The ruins of the four outbuildings were not readily visible and are presumably covered with vegetation. In the 1980 survey form, the house was described as being in deteriorated condition and unaltered.

The property is not associated with any event or personage that would qualify it for eligibility under Criteria A or B, respectively. Sadly, this property is in ruins and has been vandalized as well. Its integrity has been destroyed. It no longer can be considered eligible for registration under the terms of Criterion C: Design/Construction. No known archaeological significance is associated with the property, making it ineligible for consideration under Criterion D.



SUMMARY

BAKER-GREENLAND STONE HOUSE HA-1535

This two-story, partially-stuccoed rubblestone house--vacant and skeletal in its vandalized state--may have been built by Nicholas Baker between 1832 and 1858, or by William Greenland after 1865. He purchased small parcels of "Halls Plains" from Thomas Slade and Frances Cloman and in 1865 sold 16 acres to William Greenland. Nicholas Baker (b. 1810, d. 1896) was the fourth generation of that name. Son of Nicholas and Elizabeth Baker, brother of George W. Baker--pioneer canner of Harford County, Nicholas Baker IV owned a chair and furniture factory and did some canning himself. He had six children by his first wife and two by his second and probably built the large frame house next door on Stepney Road to accommodate them. The Greenlands owned a great deal of property in this area between Churchville and Carsins Run.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-story, partially-stuccoed rubblestone house is located on the south side of Churchville Road (Md. Rte. 22), just east of Stepney Road.

Facing north, the house is e1-shaped: the front section is 22'4" and two bays wide and 17'10" or two bays deep, with an interior brick chimney in the west end and an entrance in the east bay of the north side. The e11, whose west side is flush with the west end of the front section, is 16'2" and two bays long, and 14' deep with an interior brick chimney in its south end. The structure is mostly stuccoed, but the stucco has peeled away to reveal that at least the first story windows in the west end have cut granite lintels. A single remaining window sash indicates that windows had 6/6 sash and narrow beaded trim. The frame foundations of a front porch are extant as is the shed-roofed porch in the e11.

On the interior, the front section contains one room on the first floor with an enclosed staircase on the east and a hole for a stove in the west wall. The south section also contains one room, with a stone fireplace in the south wall. Little woodwork remains. The attic rafters are straight sawn and butted together.

"A" Also on the property are the ruins of four frame outbuildings.

STATEMENT OF SIGNIFICANCE

The Baker-Greenland Stone House was built by Nicholas Baker between 1832 and 1858 or by William Greenland after he purchased a 16-acre lot from Baker in 1865. In 1832 Nicholas Baker purchased 8 acres of "Hall's Plains" from Thomas Slade for \$37.50,¹ and in 1839 Francis Cloman sold Baker another 38 acres of the same tract for \$304. William Greenland paid Nicholas Baker \$467 for a 16-acre lot in 1865. The 1858 Jennings & Herrick Map indicates a house in this location, but local residents suggest this particular house was built by Greenland. He also purchased 82 acres of "Hall's Plains" and "Montreal" from James Anderson in 1869, and left the whole farm to his son, also named William Greenland, in 1903. The farm remained in the Greenland family until 1966.

The Nicholas Baker who may have built this house was the fourth generation of that name. Born in 1810 to Nicholas & Elizabeth Cole Baker, he was married twice, first to Elizabeth Carsins, by whom he had 6 children, and second to Mary B. Greenland, by whom he had 2 children. Nicholas Baker was the brother of George W. Baker, pioneer canner of Harford County and founder of a canning dynasty. He himself did some canning and also had a small chair and furniture factory. According to the Portrait & Biographical Record of Harford & Cecil Counties, published in 1897, Nicholas Baker was "a stalwart advocate of Republican principles" and an active member of the Methodist Episcopal Bush Chapel.

Another structure around the corner on Stepney Road is indicated as belonging to Nicholas Baker on both the 1858 Jennings & Herrick Map and the 1878 Martenet's Map. Indeed, Baker may have built this one first and then the larger frame one on Stepney Road (now owned by Miller Scarboro) as his fortunes and family swelled, or Greenland may have built the house to replace an earlier one shown on the 1858 map.

A previous Nicholas Baker had owned a stone house near this location as early as 1813 when a deed for 18 1/2 acres of "Hall's Plains"⁴ mentions "the road from the log meeting house (probably Bush Chapel) to Nicholas Baker's Stone house." The 1814 tax list confirms Baker's ownership of a 25' X 20' one-story stone dwelling and 150 acres in the Second District. Since the dimensions do not match this particular house, and since its proportions suggest an early-to-mid 19th century date, it can be presumed that the Baker-Greenland house replaced the earlier stone dwelling. Although vacant and vandalized almost beyond repair, indications--like the cut granite window lintels--of a finer existence are still evident.


