Street Log House and Farm

SUMMARY

This is a typical 19th century Harford County Farm. The log bank house and later frame barn were typical components in an agricultural network that could be found just about anywhere throughout Harford County. Today, there is no longer any farming activity at this site, reflecting the general decline suffered by small farms.

The only clues as to the history of this site come from land records. From 1851 to 1921, this property was in the hands of the Streett family, who were a prosperous group of farmers in this area of Harford County. It is quite probable that this house was constructed in the late 1850's or 1860's. Today, in 1980, it is significant, despite its alterations, as a relatively intact example of local vernacular architecture.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm complex is located off St. Clair Bridge Road, west of Maryland Rt. 24, at the end of an unpaved lane. It is approximately 100 yards south of the Deer Creek. According to the U.S.G.S. Map, the road on which this farm stands once connected with North Bend Road, west of this site. The remains of this roadway were observed and a large rubble stone retaining wall, approximately 2' thick and from 3'-5' high still exists, defining the road as it runs its course 20'-30' away from the house and barn.

The house is a bank house, with a rubble stone foundation, V-notched log walls, logs are 9"-12" wide and 6" thick and a gable end roof. It is 3 bays wide by 1 bay deep, measures 22'8" X 15'10" and has a brick interior flue projecting through the ridge of the west gable end. To the south is a 1-1/2 story frame addition, that is clad in drop siding. The main block is blind on the east and west ends, and has a center entrance flanked by 1 window in each bay, with symmetrically located windows in the second floor. When examined, the house was undergoing remodelling, and all but the north elevation had been covered by modern aluminum siding. The north still has one 6/6 window (new ones are 1/1) and its vertical board siding over the logs. There are battens over the seams on these boards and board and battens are fastened with cut nails. The entire exterior was whitewashed ~~and~~ one time.

The interior was not accessible, but the following observations were made from the exterior. The plan is 1 room down and 1 room up, and there was a large fireplace opening on the west wall.

There are a number of outbuildings, including a barn on the premises. Thirty-two feet west of the house is a shop building 14'10" X 13' 7", constructed with hewn materials and treepole rafters, but also sawn material and wire nails. This shop is also a bank type structure and has a rubblestone foundation which has been whitewashed. The older siding is covered by modern wooden shingles.

Approximately 30' west of the shop is a spring, now overgrown with weeds. It is surrounded by a stone vault with an entry way that faces south.

Approximately 70' west of the spring is a small bank-type barn, with a drive through crib. It measures 19' X 30' and has a 16' 3" drive with a 4'4" crib. The crib is 8' high and rests on 2' stone piers. Wrought iron door hinges were observed on the barn, which has a circular sawn frame with mortise-tenon and pegged joints. The roof rafters are tree poles. A mixture of cut and wire nails was found throughout the barn.


