DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Churchville Charge House is an early 20th century vernacular farmhouse with a center gable and an enclosed one-story porch which is located south of Churchville Road (MD 22) at the end of a dirt driveway leading south off the main road opposite the Campus Hills Shopping Center.

The house originally had three bays with a center entry through the porch on the north elevation. The porch has been enclosed and the entrance shifted to a side door. The two bays still visible on the second floor each have paired 2/2 aluminum windows. An arched gable window remains in the central peak of the roof on the main elevation.

A 2-story ell extends from the southwest corner of the main section. A central chimney projects from the main roof. The foundation is concrete, the exterior covering is asbestos sheets, and the roof is composition material.


