Justification for decision: (Use continuation sheet if necessary and attach map)
 The Aberdeen Community Services Building is significant for its association with educational development and community growth in Aberdeen and as a representation of the work of two well-known regional architects: Otto E. Simonson and John B. Hamme. Built as a high school in 1908, the building was expanded to accommodate elementary students in 1924. The building served as the principal educational facility until a new high school was built in 1953. A final expansion in 1935 provided additional classroom space, a gymnasium, and an auditorium. The Aberdeen Community Services Building retains architectural integrity in its configuration, materials, setting, ornamentation and interior plan. The original windows have all been replaced insensitively, the sash configuration has been downsized and the remaining opening sealed and aluminum siding applied. The original block was designed by Simonson, while both additions were developed by Hamme. Simonson and Hamme had profitable individual careers including a variety of commissions for public buildings. Like the Aberdeen School, each architect had his hand in the design of the Slate Ridge school in Harford County, a National Register listed building.


