It is a three bay wide, four bay deep, one story high, gabled roof (running north-south) frame (covered with aluminum siding) building, resting on a stone foundation, with square, tent roofed, louvered belfry, supported by a bracketed modillion cornice; square, brick, north-east corner chimney; and one bay wide, one bay deep, one story high, intersecting gable roof (running east-west) frame (covered with aluminum siding) sacristy, with east window and north entrance.

Fenestration for the building is entirely mitre arched and double-hung. Windows hold two-over-two lights, bordered by seven-over-six lights, underlined by flat wooden sills, now covered with aluminum.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

St. Michael's Church faces north on the south west corner of St. Michael's and Hardy Roads.

It is a three bay wide, four bay deep, one story high, gabled roof (running north-south) frame (covered with aluminum siding) building, resting on a stone foundation, with square, tent roofed, louvered belfry, supported by a bracketed modillion cornice; square, brick, north-east corner chimney; and one bay wide, one bay deep, one story high, intersecting gable roof (running east-west) frame (covered with aluminum siding) sacristy, with east window and north entrance.

Fenestration for the building is entirely mitre arched and double-hung. Windows hold two-over-two lights, bordered by seven-over-six lights, underlined by flat wooden sills, now covered with aluminum.

A gabled roof, enclosed entrance porch, centered on the north wall, holds an eight paneled double door, each side of which holds four arched lights. A four light, fan light is set over the entrance and a carved triangular inset is placed above it, in the "A" line of the gable of the entrance porch. The north wall of the church holds a single east and west bay window, similar to those described, which flank the projecting entrance porch. A leaden paned, bull's eye is centered above the entrance porch on the north wall and similarly on the south wall. Its central circle depicts the Mother Mary on the north and St. Michael on the south.

The west wall holds four windows, while the east wall holds three nave windows, with a cellar door placed between the two north bay windows. Its south bay holds the sacristy.

The eaves are deeply cut and feature decorative roof timbering and bange-boards decorated with carvings, on the north elevation, held by four brackets with a central gothic arch, behind which is a narrow, rectangular, louvered attic vent. Another similar vent is placed on the south wall.

STATEMENT OF SIGNIFICANCE

St. Michael's church at Poplar Springs, Howard County, Maryland, is the earliest Catholic Church standing in this community, constructed in 1880.¹ Its distinction is expanded upon by its construction in the Gothic Revival Style of the late 1800's, for it is the only structure of this style in the Poplar Springs - Lisbon area of Howard County.² Additionally, the addition of a small sacristy is important for it reflects a common practise in the building history of the United States, retaining and preserving the original architectural integrity of the building.³

History and Support

1. By the late nineteenth century the number of Roman Catholic families had increased in the Poplar Springs area to such an extent that a meeting of 20 Catholic residents was held in June, 1879 at the home of Lilbourn F. Kuhn. A priest of Woodstock College, Father Ferrari, S. J. was also present and suggested subscriptions be initiated for a new church. By June 12, 1880 the present church had been constructed and the corner-stone laid. On October 18, 1880 the Reverend Edward I. Devitt, S. J., under whom the parish or mission was placed, celebrated the first mass. Archbishop James Gibbons dedicated the church and administered the sacrament of confirmation on June 4, 1882. For the next ten years various Jesuit priests from Woodstock served as pastors and were boarded by members of the congregation. In 1892 St. Michael's at Poplar Springs and Holy Family Church at Harrisonville in Baltimore County were made missions of St. Josephs Church at Sykesville, under the Right Reverend Monsigneur James F. Nolan. Please see Item 7.

2. The western section of Howard County is noted for its fine vernacular architecture exhibited in its log and frame houses, many of which date from the mid-eighteenth to mid-nineteenth century. Very few buildings, except church edifices, feature recognizable stylistic detail. St. Michael's is particularly fortunate in having had little alteration occur and retains its late nineteenth century charm.

3. Alteration, however, has occurred with the addition of the intersecting gabled roofsacristy, creating an "L" plan, rather than an "I" plan. This addition, however, has been constructed to the scale of the original building and is an integral part of it. Rather than superimposing itself on the the original structure it blends gracefully into the structure, maintaining only a small, one room addition off the south bay of the east wall, which features a matching pitch to its gable roof and a similar height to its walls. This addition, as well as the original structure, has been covered with a common exterior siding.

4. NOTABLE FEATURES, HISTORICAL SIGNIFICANCE AND DESCRIPTION OPEN TO PUBLIC

St. Michael's Catholic Church is a late 19th century Victorian church very similar in style to other rural religious edifices of the period which dot the Howard County countryside.

Facing N. the facade has a single storey projecting ~~apron~~. The A roof has exposed rafters at the eaves which are carved in a scalloped pattern. The main door to the ~~apron~~ is of recent date but is surmounted by a simple segmental arch with three paired stained overlight. On each side of the ~~apron~~, at the N. wall of the main block, is a single lancet arched window containing a fixed (?) sash of rectangular panes. This same window design is repeated in the four windows of the E and W elevation.

The roof plan is A frame with an interior bellry at the N. end. This




