### Section 7. Description

Included on the original inventory form for Gaines A.M.E. Church was a one-paragraph description of an earlier building that was supposedly an 1860's African American church/school. That building is about to be torn down, and so a visit was made to the site to record the building in more detail and hopefully determine if it was an early church/school. Unfortunately, years of neglect had finally taken their toll and the only wall still vertical was the front wall. The roof had collapsed taking out the second floor and the side and rear walls leaned at a 45 degree angle. Given the current condition of the building, only a very basic investigation could be made and a photo taken to record its last days.

The two story frame building was one room wide and two rooms deep with a front gabled roof, and faced northeast on the southwest side of Montgomery Road. It is located only about 50 yards from Gaines A.M.E. church and is surrounded by an overgrown African American graveyard with some marked and many unmarked graves. In its final days, the building was covered with brick patterned asphalt shingles over wooden German siding. There was a central door on the first story of the front façade, but any additional fenestration on the other facades is now a mystery. According to the original inventory form, the building was four bays deep. It sat on a partial stone foundation and had some sort of central brick chimney which, at the time of the investigation, had collapsed into the building. The interior of the structure was plastered over circular sawn lath. Framing timbers were also circular sawn, and the building was constructed with fully machine made cut nails.

Construction techniques and building technology are consistent with a construction date any time between 1865 and 1900. Given the deed cited in the original form which dates to 1866 and the fact that a "school house" is noted on the 1878 Hopkins



map in this location, it seems likely that this building was constructed between 1866 and 1878 specifically as a school and/or church building for the African American community as was specified in the deed. The earliest graves in the cemetery probably also date to this period. The neglect and demolition of this building and the surrounding cemetery is a great loss to the post-Civil War history of the African-American community and Howard County as a whole

Gaines A. M. E. Church faces south on the west side of Montgomery Road, just south of its intersection with Route 95. It is a one bay wide, three bay deep, one story high, gabled roof (running north-south) frame (covered with asbestos shingles) Romanesque church, resting on a stone foundation, with one story high, one bay deep, frame, enclosed, entrance porch, whose roof begins as a gable, but terminates in a central, tall, square, frame (covered with asbestos shingles), tent-roofed steeple, crowned by a cross. A one-story high, semi-conical roofed, semi-octagonal, frame (covered with asbestos shingles), apse, resting on a brick and cinder block foundation, is placed on the center of its north wall.

Roman-arched, double-hung windows feature a cross motif, while the rectangular, double-paneled entrance door is surmounted by a stained glass fan light inscribed, "Gaines A. M. E. Church", Founded in August, 1893, The Church was rededicated March, 1971, the Reverend W. J. Dunlap, pastor.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Gaines A. M. E. Church faces south on the west side of Montgomery Road, just south of its intersection with Route 95. It is a one bay wide, three bay deep, one story high, gabled roof (running north-south) frame (covered with asbestos shingles) Romanesque church, resting on a stone foundation, with one story high, one bay deep, frame, enclosed, entrance porch, whose roof begins as a gable, but terminates in a central, tall, square, frame (covered with asbestos shingles), tent-roofed steeple, crowned by a cross. A one-story high, semiconical roofed, semi-octagonal, frame, (covered with asbestos shingles), aspe, resting on a brick and cinder block foundation, is placed on the center of its north wall.

Roman-arched, double-hung windows feature a cross motif, while the rectangular, double-paneled entrance door is surmounted by a stained glass fan light inscribed, "Gaines A. M. E. Church". Founded in August, 1893, the Church was rededicated March, 1971, the Reverend W. J. Dunlap, pastor.

Southwest of the 1893 church building stands another one bay wide, four bay deep, two story high, gabled roof (running east-west) frame covered with asbestos tile, building with central cross-paneled, rectangular, east entrance, believed to be the earlier church-school house building of the 1860's.

BUILDER/ARCHITECT

Gaines A. M. E. Church is significant to the black history of Howard County and the State of Maryland and architecturally noteworthy as an example of a simple frame Romanesque Revival Church of the nineteenth century. Its history at this site began on November 12, 1866, when James W. Tyson and his wife, Elizabeth of Baltimore County deeded this small tract of land to the African Methodist Episcopal Church of Elk Ridge Landing for one dollar. It was part of a tract called Rockburn and was deeded "together with the buildings and improvements thereupon erected, made or being".....

The following interesting provision is found in the old deed conveying the property to the church:

...provided that if the grantee herein named shall use the land conveyed or any part thereof, or shall voluntarily permit the same to be used for any other purpose than for the purposes of a church and school house under the management and direction of persons of African descent and such other purposes (if any) as a church or school house belonging to the African Methodist Episcopal Church is generally used for or if the said grantee shall sell, convey, lease or mortgage the said land, or any part thereof, or shall for the period of five (5) consecutive years fail to use the same for the purposes of a church, then this deed shall be void....."

A building is noted in this general location on the 1860 Martinnet Map (Please see Attachment 4) belonging to James Tyson, who initially conveyed the property to the A. M. E. Church of Elkridge Landing, while the 1878 Hopkin's Atlas indicates a school house at this location.

The two story high, one bay wide, four bay deep, gabled roof (running east-west) frame (covered with asbestos tile) building lying southwest of the present church is probably the Church-School House building of 1866.

The cornerstone of the present white frame Romanesque Revival Church stems from 1881, which date is noted on its cornerstone when rededicated in 1971. Residents of Lawyers Hill recall listening to the singing voices coming from Gaines A. M. E. Church on warm summer Wednesday evenings, when its congregation met for mid-week prayer and praise. Such memories lend a particular enchantment to an already colorful area.

The buildings on this site are therefore important to Howard County through their association with the County's black religious history and architecturally represent mid-nineteenth century Howard County vernacular architecture, as well as the late nineteenth century Romanesque Revival.

As such, Gaines A. M. E. Church should be recommended for inclusion to any local historic landmark legislation the Citizens of Howard County may initiate, as well as the State Critical Areas Program and the National Register of Historic Places.


