Capsule-Summary

This small but graceful building was constructed in 1914 as a post office for the village of Perryman. It was common practice in the 19th century to locate a post office in a store, so construction of this building marks a departure from the usual. It is one of the few remaining village post offices left in an older building in Harford County.

## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This structure is located on the south side of Michaelsville Road slightly north of the intersection with Railroad Avenue. The building faces northeast and is one story high. It is of frame construction and has a hipped roof and rests on a concrete foundation. It is two bays wide at the front (northeast) with a doorway in the south bay, and three bays long, with the last bay being a shed roof addition. The roof overhangs the front elevation to create a sheltered porch, and the roof is supported by posts with chamfered posts with chamfered edges and tops and bottoms cut to represent simple bases and capitals. The porch is partially enclosed at the top by vertical planking above the level of the supporting posts. The exterior has asbestos shingles and a roof of asphalt shingles. The raised porch deck is of wooden planking.

The interior has been greatly altered over the years, but it still retains a wainscot of 2" varnished planking. All other original fabric has been removed.

The postmaster here, Mrs. Laura McComas Lee said that her father Isaac S. Lee owned the sawmill where the lumber for this post office was cut. The structure was erected in 1914 specifically for use as a post office. The builder is not known.

## STATEMENT OF SIGNIFICANCE

Perryman is a small village tucked away in a quiet section of the County that abuts the Aberdeen Proving Ground. It is only a short distance from the busy Route 40 corridor, and high speed train tracks run right through the center of the settlement, but Perryman, surrounded as it is by farming fields, has the look of a rural outpost. One of the buildings usually associated with small villages is the post office, and today unlike some of Harford County's cross road villages (Federal Hill, Prospect and Dublin) Perryman still has its own branch. Apparently the first post office came to Perryman between 1858 and 1878, since the Martenet map of the later date indicates the village as "Perryman P.O." and one building is identified as "Store & P.O.". The present structure continues an aspect of small town living that is rapidly disappearing in the face of modern efficiency.

Despite its small size and lack of exterior decoration, this post office building shows an awareness of style for the period in which it was built. The hipped roof gained favor with the advent of the Colonial Revival in the late 19th century, and the ~~XXXXX~~ choice of this roof type is an interesting one. It also harmonizes nicely with the office building of the F.O. Mitchell Co. across the street (HA-1659) although it is not known which building was constructed first. Also, the posts supporting the roof are not the turned "Victorian" type, but are more closely identified with a sort of simple classicism. Whoever designed this structure had an acquaintance with prevailing architectural fashions.





