DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The house is a two story, frame structure with a three-bay, main (south) facade. It sits on a stone foundation. At either end are internal chimneys. The siding is tongue-and-groove.

The central doorway has a high transom light. The flanking windows are 4/2 double hung sash with large panes of glass. The second floor windows are 2/2 double hung sash.

A shed porch with square posts, chamfered on the edges, extends across the main facade.

At the west end an addition has been added recently. The one story rear el appears to be contemporary with the house, however.
