Apparently, the house on the farm is an early-20th Century replacement of an earlier structure. However, several farm buildings remain. Chief among these is a frame bank barn on a fieldstone foundation. The "windows" are painted on, and there are three, cupola-type vent caps along the ridge of the roof.

A large, 20th Century, block dairy barn sits nearby.
