This is a narrow, two-story frame house, built in the shape of an "L". The older section (reportedly of log construction) is a low, two-story wing, that extends to the rear of the main house. The main house is a narrow building, of three bays, that faces east on Rte. 28. There is a center gable and a central door. A one-story, open porch with bracketed posts spans the front of the house. Chimneys are stove-type flues, located in each end of the building. There is a metal windmill tower behind the house.

New siding has been placed over the old German siding since the time of the survey.
