This two story log house was built as the home of a Black landowner, Lewis Brown. Its facade consists of three bays. In plan, the interior contains two rooms down and two up, heated by wood stoves. Behind the house once stood the several small outbuildings essential to farm life. This small farmstead with its log house was typical of those occupied by landowning Black families in the last decades of the 19th century and into the 20th.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story log house stands abandoned in the midst of woods on the west side of an old lane that led northward from the new Big Woods Road to the old Big Woods Road. The house is in increasingly deteriorating condition since it is open to the elements. Yet many of its timbers remain in good condition and the house gives us a glimpse into the construction and design of the houses of black landowners in the years following emancipation.

As with all of those houses in the 19th century, the grounds around the dwelling were used to support the family. The outbuildings and garden places around this house give evidence today of those use. In front of the house remains a portion of the old grape arbor and old pear and apple trees still stand along the northern side of the house. A hen house with yard, a privy, another grape arbor and a log outbuilding stand behind the house. The outbuilding measures 11' x 8'7", has no windows and was probably the meat house. In front of the house, as well as behind it are colorful, climbing rose bushes.

The dwelling itself is three bays in length with a door centrally located, flanked on either side by a window opening. This creates the bilateral symmetry that was popular to the last half of the nineteenth century. The windows contain double-hung sashes with 6 x 6 panes and were protected by wooden shutters. The massive logs measured approximately 8 to 11 inches in thickness and 6 inches in width. They were of hardwood either chestnut or oak. At the corners they were joined by V-notches. The chinking between the logs contained red sandstone rocks, perhaps chips from the Seneca Rock Quarry. The cornices were boxed with plain boards and the gable roof covered originally with wood shingles, now with tin. The entire exterior of the house had been whitewashed. There is no evidence of pegging; instead the logs were fastened to the frames of the openings by machine-cut nails.

In plan the house consists of two rooms and a hallway downstairs and three rooms upstairs. The house is large in size, measuring 25'4" x 20'2". One room downstairs (the parlor) measured 13'5" x 14'5", while the kitchen measures 9'8" x 18'. A central stove flue was built between the kitchen and parlor with openings for stove pipes in each room. All of the walls inside were lathed and plastered as was the ceiling. In the parlor the walls were wainscotted with 1" x 4" boards midway up the wall and were painted green. All of these features disguised the fact that this was a log dwelling.

In the kitchen was a small closet, 4'3" x 3'5", which probably served as a pantry. A door led from one gable end to the outside. Next to that door was the outside opening that led down to the cellar. Shelves still remain on the walls.

The stairs which are found at the end of the hallway in the rear of the house lead up to a small room (9' x 12'8") which may have been a bedroom. From this room two doorways lead into the other two rooms upstairs, one was a small bedroom measuring 9'9" x 12'6" with one window which looks out from the front of the house. The large room upstairs which extends from the front to the back of the house with a

STATEMENT OF SIGNIFICANCE

According to the deed, EBP 10/257, Lewis Brown purchased this property of 6 acres from the Trustees of the Hempstone estate in 1873. This establishes Brown as one of the earliest of the Black landowners to have settled in the Big Woods area. He purchased the land directly from the representatives of the white family that had owned much of the future Big Woods community during the antebellum era. He bought this land at the same time as his neighbor, Henry Thomas Onley, whose deed was recorded on the preceding page in the deed book.

The log house that he built and lived in after purchase of this property still remains in relatively good condition even after abandonment. It has been described in considerable detail since it is one of the few log houses remaining in the Big Woods community and in upper western Montgomery County.

In terms of size the measurements of this log house are comparable to those of log houses of white families in the county, such as the Horine log house on Peachtree Road. These houses are evidence of the similarities in housing conditions of both black and white landowners of moderate means in the late 19th century.

window in each length wall measured 11'2" x 19'1". It is the only upstairs room that was heated and presumably was the parents' bedroom.

Florence Hallman of the Big Woods community remembers that the small front room was the bedroom of her friend, Matilda Brown, daughter of Lewis Brown.

Over the front door was a small shed porch supported by plain, rectangular posts. The back door was sheltered by an enclosed shed which served as storage space as well as an entranceway.
