The house is a two story, frame structure with a three bay main (west) facade with a central gable. At either end are internal chimneys. To the east is a two story wing with a two story, galleried porch. The main section has 1/1 double hung sash with segmentally arched window heads. The rear wing has 6/6 double hung sash. A one story log wing, perhaps the oldest part of the house, extends to the east; it has been covered with asbestos shingles.

East of the house is a frame bankbarn with vertical plank siding.
