DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The house is a two story, four-bay, frame structure. The main (south) facade has the doorway in the second bay from the west the windows are 9/6 double hung sash on the first floor and 6/6 on the second. The clapboards are random-width. The window frames consist of a beaded board with a quarter round moulding surround.

At the west end is a two story, stone chimney with a brick stack. At the east end, the chimney is internal. The foundation is stone and on the west end, the basement is exposed. The boxed cornice has an ogee bed moulding.

A later two story wing extends to the north.

Northwest of the house is a log meathouse; the gable ends are board-and-batten. Two outbuildings stand west of the house. One is a log barn, now a corncrib. The roof has been raised and drive-through sheds have been added along either side of the barn.

The springhouse/dairy is of stone and frame construction. The stone section is 1-1/2 stories. The ground floor room has plastered walls; the ceiling is presently lathed and plastered below the joists, but originally, the lath were nailed to the loft floorboards, and the ceiling was plastered between the joists, which were exposed. The lath are all hand-split. The joists are mortised into the gable-end walls; on the east end, the three center joists extend through the wall to form a framework for a platform or porch at the loft level. In the southwest corner, an angled beam provides a base for the small fireplace in the loft above. The roof framing consists of rafters birdmouthed over the plate and mortised, tenoned, and pegged at the ridge. The frame section added at the east end is recent, the members being sawn and nailed together.
