DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The house is a 2-1/2 story, three bay log house with a two story, one bay frame addition at the east end. The facade has two dormer windows; there is one internal chimney on the west end. The cornice is boxed, but not returned into the end gables. The door has narrow sidelights.

Behind the house is a second framed section with a returned cornice; it has a smaller internal chimney on the west end; a porch is recessed into the northwest corner. The kitchen wing extending ^{to} the east has a chimney on the north wall and a shed-type roof.

The internal arrangement consists of a center hall with one room on either side and a U-shaped staircase. The west room has a mantelpiece with pilasters and frieze; in the east room a similar mantelpiece is located in the northeast corner.

The kitchen wing has had the ceiling removed and fireplace closed.

The house is heated by coal grates, stoves and fireplaces.

There are several outbuildings on the property including a shed with bargeboards and a bankbarn. The barn is constructed with hand-hewn framing members, mortised together and pegged; it has an entrance porch.
