DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The house is a 2-1/2 story frame, L-shaped structure with a gable on the main (west) facade that breaks the line of the eaves. Porches extend across the facade and between the legs of the "L." The supports are bracketed. A small round window decorates the facade gable. Internal chimneys are on each of the main end gables.
