DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The house is a two story, Federal-style structure with late nineteenth-century additions. The original structure was five bays wide and one room deep with internal end chimneys. An addition was made extending the house one bay to the south and cross gables were added, obscuring the two south bays of the original structure.

The entrance, now off-center, has transom and side-lights. The staircase rises along the north wall of the hall with a sharp turn at the northwest corner. The Federal style newl post and balustars remain intact. On the exterior, the windows have moulded, cornice-like architraves; the sash, ^{are} 6/6 double-hung. The cornice is boxed. The roof is a straight gable without returned cornices in the gable ends.
