DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a typical, local frame farmhouse with some decorative elements. The main (west) facade has three bays, with a low center gable and a central doorway. The chimney is a stove-type flue on the north interior end. A one-story, open porch with turned posts and brackets spans the front of the house. Sheathing appears to be German siding. There is a two-story wing on the rear. There are some frame sheds nearby, and a 20th Century block dairy barn (abandoned.)
