9. Description: This five bay, two and a half story seneca sandstone house is in ruins. It faces north on Sugarland Road. Constructed of uncoursed sandstone with corner quoins, the windows, doors, and gable roof have been removed. The window and door openings have stone sills and lintels. Two small windows flank the interior east and west gable end chimneys.

10. Significance: This handsome shell of a building has been continuously in the possession of one family since its erection in 1808. Captain Robert Doyne Dawson, a veteran of the Revolutionary War, built the house and enlarged upon his estate until he owned some 775 acres in the area around Dry Seneca Creek. When he died in 1824, his lands were divided among his four sons, George, Benoni, Thomas, and Joseph who continued to farm the land and to engage in milling. One of them was active in government; George Washington Dawson represented the area in the State legislature, and held the offices of trustee of public schools, trustee of the poor, Justice, collector of taxes for the 5th district and State assessor for Montgomery County.

By 1875 a new house had been constructed north of the "Dawson House" for Frederick A. Dawson, son of Dr. Benoni Dawson. Frederick and his sisters deeded their land to their nephew, Lewis P. Allnutt, in 1910 and the property has remained in the Allnutt line of the Dawson family since.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This five bay, two and a half story, house is in ruins. It faces north on Sugarland Road.

Built on stone foundations, this house is constructed of uncoursed Seneca sandstone with corner quoins. The windows and doors have been removed as has the gable roof. These openings all had stone lintels at one time, although many are missing now. The interior end chimneys, with brick stacks, are visible at the east and west gable ends. There are two small windows at the gable ends flanking the chimney.

STATEMENT OF SIGNIFICANCE

This building, and the surrounding property, has been continuously in the possession of one family since the house's erection. Captain Robert Doyme Dawson, veteran of the Revolutionary War, is credited with its construction in the year 1808. The house is situated on parts of "Cole's Choice", "Addition to Cole's Choice", "Long Looked For Come At Last" and "Tunis' Purchase", obtained by Captain Dawson from William C. Dawson.¹ (Although the deed of conveyance is dated October 18, 1810, this does not preclude the possibility of an earlier date of ownership, nor does it refute the inscribed date stone upon the building.) The acreage was expanded upon, through purchases and inheritance, until Robert D. Dawson had accumulated some 775 acres in the area of Dry Seneca Creek. Family tradition claims that Robert Doyme Dawson never lived in the house. No substantive evidence has been uncovered to either corroborate or discredit this situation.

Capt. Dawson died on August 13, 1824. His various heirs-at-law then petitioned the courts for an equitable division of the lands. Ruling that "...the relative situation of the wood to the cleared ground and improvements makes it impossible to divide (the) land into more than three parts", the court-appointed commissioners proceeded to partition the property into four lots, being

- The Widow's Dower (to Henrietta Dawson), 103 acres of "Conclusion" and "Long Looked For.."
- Lot 1, 149 acres of "Conclusion", Long Looked For..." and "Tunis' Purchase"
- Lot 2, 149 acres of "Tunis' Purchase", Long Looked For...", "Addition to Partnership", "Cole's Choice", and "Addition to Cole's Choice"

(These three lots were contiguous to each other, and formed the lands immediately surrounding the house.)

- Lot 3, lying in two separate pieces;
 - a) 178 acres of "Mother's Delight", "Addition to Mother's Delight" and "Fair Prospect"
 - b) 198.5 acres of "The Resurvey on Silome"

(Lot 3 lies separate from the above. Lot 3a is the property inherited by Robert D. Dawson from his father, Thomas Dawson, and contains the family CONTINUE ON SEPARATE SHEET IF NECESSARY burial ground of Thomas Dawson and his descendants.)²

DAWSON HOUSE

Beginning in 1830, Thomas Dawson of Robert, son of Robert Doyne Dawson, began accumulating the other heirs' interests in their father's land, [3] He eventually sold off Lot 3 in 1835 (reserving the right to the family graveyard), and was thus left in possession of Lots 1 and 2 (including the widow's dower), being the land on which the subject building is located,

Thomas Dawson of R died on April 15, 1852, and by his last will and testament, bequeathed the property to his brother Joseph N. Dawson, who had been the implied co-owner of the property during Thomas Dawson's lifetime, [4] However, as Joseph Dawson states in his will, composed on November 15, 1864,

...this devise and bequest tho' absolute on its face and without condition in its terms was upon the trust and confidence that I would convey to my brother George W. Dawson to whom my said brother Thomas Dawson was largely indebted, all that part of a tract designated as Lot No. 1, containing about 200 acres... and that by some fit instrument I would convey to the children of my brother Dr. Benoni Dawson, lately deceased, all the rest and residue of said lot No. 1 and the whole of Lot No. 2... the lands so to be conveyed to the children of my brother Benoni Dawson to remain in my occupancy and possession during the term of my natural life and to come into the occupancy and possession of my said brother's children at my decease, [5]

Thus it appears that while the various offspring of Robert Doyne Dawson had vested their interest in the property to Thomas Dawson, there existed an unwritten agreement of co-ownership among the several Dawson brothers. This situation is reiterated by a passage written by George W. Dawson on February 13, 1871, in which he states that

...For nearly forty years before the death of my brother Joseph [around the year 1869] we lived together jointly engaged in farming and milling. His death terminated our partnership, and unwilling at three score and ten to commence as it were the world anew, I sold my farm to my nephew [Frederick A. Dawson] and make my home with him, [6]

George Washington Dawson was born in 1799, and, like many of the Dawson brothers, never married. He represented the area in the State legislature and held the offices of trustee of public schools, trustee of the poor,

Justice, collector of taxes for the 5th district and State assessor for Montgomery County, [7]

Frederick A. Dawson, son of Dr. Benoni Dawson, next took possession of the farmstead, living with his uncle until the death of George W. Dawson in 1875. By this time, however, a new house had been constructed upon the property, north of the subject building, and it was this structure that was occupied by Frederick Dawson. (Presumably the older Dawson house continued to be occupied.) The bachelor Dawson lived with his sisters Susan and Adelaide Dawson, to whom, being indebted for the sum of \$8,000, he conveyed on April 10, 1900, a partial interest in the property which he "purchased from the heirs of the late Benoni Dawson and George W. Dawson", [8] However, by his will, Frederick A. Dawson devised all his interest in the property to his nephew Lewis P. Allnutt, and he desired that his sisters "...who own the other interests in... the land will at their decease give the same to our nephew Lewis, whom we have raised as our child," [9] Frederick Dawson died in 1907; his sister Susan Dawson in 1908; and Adelaide Dawson in 1910. And, on December 20, 1910, the various Dawson heirs combined to convey the undivided portion of Frederick A. Dawson's land holdings to Lewis P. Allnutt, [10] The property has remained in the Allnutt line of the Dawson family since,

This is a ruined, two story structure with a (north) facade. The doorway is in the center bay. At either end are flush gable, brick chimneys. The building is laid up in uncoursed sandstone with cut quoining blocks. The door and window heads on the first floor are segmentally arched and on the second floor, flat arched. They are made up of cut sandstone blocks.

The bankbarn, across the road from the house, was built in 1877. It measures 40' x 60'.




