This once handsome two story frame building was constructed as the meeting hall for the Odd Fellows' Society, a Black benefit and social organization. Its imposing design and spacious interior reveal the relative affluence of the Black landowners in the Boyds community, who comprised the Society. This is one of the few structures of such organizations in historical Black communities to have survived in Montgomery County.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This abandoned, once handsome frame building stands on the west side of White Grounds Road. It is now in derelict condition. The interior has been thoroughly vandalized, and the windows knocked out.

The building consists of two sections. The front block is three bays in length and one bay in depth. To the back of it is attached a two story ell, both sections were built at the same time. The balloon frame of the house is covered with weatherboards, which were painted grey. The roofline is accented by a cross gable pediment which contained a small window in a diamond design. Similar windows in the attic of each gable end give the building a more attractive appearance. The other windows in the building contain double hung sashes with two over two lights. The front door is relatively plain but is accented by a transom light.

The interior of the building consists of three rooms down and three up. On the south side is the large auditorium or gathering room for the members of the Odd Fellows' Society. It had been thoroughly vandalized but a old piano with carved legs does remain. On the north side of the building is a small room in which a bar had been set up. In the bar a boxed stairway leads to the room above and above the auditorium are two rooms, which were presumably used as private meeting rooms for the members. The woodwork inside the building consists of plain tongue and groove siding for petitions. In the auditorium, there is wainscoting. The rooms downstairs and upstairs were heated by stoves which were piped in to a brick flue ascending between the auditorium and the smaller rooms on the north side.

STATEMENT OF SIGNIFICANCE

This parcel of property is shown on the property map but there is no deed recorded for this tract of land. Therefore, no title search is possible. Nonetheless, the building itself can be dated because Mrs. Edna Duffin Johnson who was born in 1891 in the White Grounds community recalls that this building was constructed for the Odd Fellows' Society when she was in her 20's. That is, it was probably built between 1915 and 1920, as best as she can remember.

The principal significance of this building is that it is a physical vestige of one of the organizations of the historical Black community. Due to the loss of population in this community, there have been no younger members to replace the older ones, and the Society exists no longer in the White Grounds community. This building however does remain and its imposing design and relatively handsome appearance -- when it was maintained -- reveal the prosperity of the Black community in the White Grounds community.

Like the Loving Charity Hall in the Martinsburg community, and in the Jerusalem community, the Odd Fellow Lodge was one of the principal centers for the Black community. This is one of the few buildings of that Society that remain standing in rural Montgomery County.







WHITE GROUNDS COMMUNITY, c. 1900-1925


