The house is a two story, frame structure on a stone foundation. The main facade is three bays, although the west bay is a bay window--not a plain sash. The bay continues into a hexagonal roofed tower that projects above the roof line. The roof is covered with patterned slate tiles. At the east end is a two story bay. The sheathing is tongue and groove. The windows are 2/2 double hung sash. To the rear is a two story el.
