The mid section of the house is the oldest (now obscured by later additions), with the present main block built about 100 years ago. The old house is a story and a half, frame building, three bays wide with an enclosed porch. The chimneys rise between the two rooms and at the north end (where the base is obscured by another addition). The windows are six over six double hung sash. The main block of the house is two stories, with a three bay facade. The doorway in the east bay has a transom and sidelights and double doors with arched, moulded panels. The ground floor windows are two over four double hung sash opening to the porch floor. The other windows are two over two double hung sash. The window heads are pedimented, with moulding along the sides of the pediments. The eaves and raking cornices are bracketed. The chimney at the west end is internal.

Behind the house is a log meat house, partially in ruins. there is also a large frame barn to the west of the house.

The Ulysses Griffith farmhouse is significant as an example of the Victorian influenced architecture of the later nineteenth century. The house has some very attractive Victorian architectural detailing, including the bracked eaves, rounded windows in the gable ends, pedimented windows and an ornately decorated victorian porch. The original structure, located in the middle of the present house and obscured by later additions, was built about 1830 as a tenant house.¹ The main block of the house was built by Ulysses Griffith II (son of Ulysses Girffith I, the owner of "Retirement") about 1876.² Ulysses II obtained lot #3 in the division of his father's land after his death in 1870.³ Then in 1872, Ulysses II purchased parts of tracts of land referred to as "Griffith's Chance," "Water's Discovery," etc. for \$2,315. This had been part of his father's land holdings designated for sale.⁴ His farm then totalled 289 acres. In 1879, Ulysses purchased an additional 86 acres, bringing his total acreage up to 375.⁵ The house is also significant as the home of a member of the Griffith family, who were among the earlier settlers to this area and had extensive land holdings. The Griffith family has been identified with Montgomery County since Henry Griffith I came to the area before the Revolutionary War.⁶

When Ulysses II died in 1929 he left his property to his wife, Blanche and his son, Ulysses III. Further instruction of his will stated that the farm be passed on to Ulysses IV after the death of Ulysses III.⁷ Ulysses IV, grandson of the original builder (of the main block) was later conveyed the farm on 375 acres. Ulysses IV was a farmer and the Chief Clerk of the Circuit Court of Montgomery County. He also represented the county in the House of Delegates and was one time the chairman of the Upper Montgomery County Planning Commission.⁸ The farm remains in the Griffith family to this day. It is now the property of Ulysses IV's children, Jane Griffith Evans and Ulysses Griffith V.





SITES NOT RECOMMENDED FOR REGULATION UNDER THE

The following sites have been reviewed by the Montgomery County Historic Preservation Commission and were found not to merit designation of the Master Plan for Historic Preservation. If not included in the Master Plan, these resources may be removed from the Locational Atlas and Index of Historic Sites in Montgomery County. If removed from the Locational Atlas, the sites will no longer be governed by the Moratorium on Alteration and Demolition, Section 24A-10 of the County's Historic Preservation Ordinance. The sites will, however, remain on the Maryland Historical Trust's Inventory.
