Behind the house is a stone spring house. The frame barn and corn crib have been rebuilt by the present owner.

The Bushrod GArtrell farmhouse is significant as an example of the vernacular architecture of rural Montgomery County built prior to the influence of the Victorian style. The house was built sometime between about 1850 and 1868. It sat on 150 acres of tracts referred to as "John & Sarah", "Addition to Brooke Grove", "Plummer's Content" and "Freeland." This land had been in the family for many years. Bushrods grandfather, Nathan Musgrove owned it and after his death in 1823 it was conveyed to his daughter, Rebecca and her husband, Caleb Gartrell. Rebecca and Caleb, Bushrod's parents, lived here and farmed the land until their deaths (Caleb in 1845 and Rebecca in 1867). Bushrod gradually acquired the full 150 acres. The first deed for portions of this property was conveyed to Bushrod in 1846, one later in 1855. By the time of his mother's death in 1867 he had acquired the full acreage.¹

In 1870, after the death of Rebecca and Bushrod himself, an equity case was brought to court to determine the future of the family farm. During this time testimony concerning the property was given. Edward W. Owen, a Unity farmer residing one mile from Bushrod's farm stated, "The farm was very poor when it came into his (Bushrod's) possession. There was a small indifferent house in which he lived and perhaps an old stable. ... The land had been tenanted out and had been badly used. ... Bushrod Gartrell improved th land very much. He put up some good buildings-- a new dwelling, a barn, a dairy, and a tenant house and all the necessary buildings that a farm should have."² Unfortunately, Mr. ownes does not say when the new buildings went up. Perhaps a more accurate date for their construction would be 1855 - 1865

Bushrod left a wife, Manelia and a son, Edgar when he died in 1870 (along with other heirs). Following the equity, his wife and son acquired th farm. Edgar owned the house see attachment sheet




The following sites have been reviewed by the Montgomery County Historic Preservation Commission and were found not to merit designation of the Master Plan for Historic Preservation. If not included in the Master Plan, these resources may be removed from the Locational Atlas and Index of Historic Sites in Montgomery County. If removed from the Locational Atlas, the sites will no longer be governed by the Moratorium on Alteration and Demolition, Section 24A-10 of the County's Historic Preservation Ordinance. The sites will, however, remain on the Maryland Historical Trust's Inventory.

The following sites were found by the Preservation Commission to be too greatly altered from the period of their architectural or historical significance or not to meet Ordinance criteria for designation.
