Description:

The Emory Methodist Church, South (now Oakdale-Emory United Methodist Church), constructed in 1914, was previously surveyed by the Maryland-National Capital Park and Planning Commission (M-NCPPC) in 1975 and by Sugarloaf Regional Trails in 1979. The property was included in the Montgomery County Master Plan for Historic Preservation in 1980. In 1979 the property consisted of the church building with a concrete block addition, two parsonages and one modern education building. Since the prior survey, a large modern church was constructed on the property and the wood clapboard siding of the original church has been covered with vinyl siding.

The concrete block addition to the original church was constructed in the late 1940s and extends from the rear, or east elevation, of the church with a cross-gable roof in a nave-trancept configuration. It is 1½-stories in height with a full-basement level, a slate roof and circular vents in the gable ends, echoing the quatrefoil windows in the gable ends of the original section of the church. The addition is 5-bays wide and 3-bays deep with vinyl 6/6 double-hung windows.

The modern education building discussed in the prior survey form was constructed in 1961. Attached to the south elevation of the education building is a large modern church. Constructed circa 1985, the modern church is a brick cross-gable structure with a wooden steeple.

National Register Evaluation:

The Emory Methodist Church, South, constructed in 1914, is eligible for the National Register of Historic Places under Criterion C. This resource meets Criteria Consideration A, as it is a religious property which derives its primary significance from its architectural distinction. The building is a good example of an early twentieth century religious structure with Shingle and Victorian Gothic influences. The building represents typical rural or suburban church construction, with an L-shaped plan, front-gable orientation, ornamental bell-tower which projects from the front facade and variety of exterior siding materials. This church type was not heavily ornamented, with adornment limited to paint, cladding materials, trim, tower and windows. Though the building has a concrete block addition on the rear elevation, it is of compatible scale and massing to the original portion of the church.



The property is not eligible under Criterion A, as research conducted indicates no association with any historic events or trends significant in the development of national, state, or local history. Historic research indicates that the property has no association with persons who have made specific contributions to history, and therefore, it does not meet Criterion B. Finally, the structure has no known potential to yield important information, and therefore, is not eligible under Criterion D.

Verbal Boundary Description and Justification:

The National Register boundaries of the Emory Methodist Church, South follow the current property lines of 3515 Emory Church Road (Tax Map HS 563 / Parcel P156). This 3.41 hectare (8.43 acre) parcel is bounded on the north by Emory Church Road, on the east by adjacent parcels, on the south by Olney Manor Recreational Park, and on the west by Georgia Avenue (MD 97). The boundary includes the original church, the two parsonage buildings and the 1961 education building with the attached circa 1985 modern church. The 1914 church building is the only contributing structure within the boundary, all other structures are non-contributing. According to deed research, the property was originally part of a .7 hectare (1.75 acre) parcel which was granted to the Emory Methodist Episcopal Church in July of 1914. The size of the property increased to 2 hectares (5 acres) in 1960, and to 7.3 hectares (18.11 acres) in 1970. By 1985, the size of the property was 4.25 hectares (10.51 acres) which was reduced to its current size of 3.41 hectares (8.43 acres) in 1986.





9. Description: This Victorian Gothic four bay by five bay, one-and-a-half story, L-plan church is set back from Route 97, facing north. This church has white clapboarding at the first level and green wooden shingles at the gable ends. The north (front) door is set at an angle. There are one-over-one Gothic stained glass windows on the north and east elevations. The north and east gable ends have large stained glass windows with quatrefoil design. At the northeast corner there is a bell tower with a six-sided spire roof. The church has an intersective gable with slate covering. There is a three bay by five bay, one-and-a-half story cinderblock addition on the north elevation.

10. Significance: This church building is the seat of a congregation that has had continuous existence since 1801. The original church, a small frame structure of simple styling, was erected in 1801 and named Emory Methodist Church South. Contributed furnishings were handmade.

By 1876 the church was part of the Rockville Circuit which also included Goshen, Brookeville, Rockville, Potomac Chapel, Concord, Gaithersburg, and Barnesville. In 1884 the circuit was divided, leaving Emory with Rockville, Goshen and Brookeville. In 1891 another division resulted in the Goshen-Emory Circuit.

The present building was constructed in 1914 with additions about 1950. The old church, at the intersection of Cashell Road and Emory Lane, was converted into a private residence, now bearing no resemblance to its original appearance.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This Victorian Gothic four bay by five bay, one and a half story, L-plan church is set back from Route 97 and faces north.

Built on cinderblock foundations, this frame structure has achieved a polychromatic exterior through the use of white clapboarding at the lower half and green wooden shingles above. A three bay by five bay one and a half story cinderblock addition on the south elevation expands the original frame church structure. The front door is set at an angle in the one story frame addition at the northeast corner. Six poured concrete steps with a black wrought iron handrail lead up to the northeast (front) double door. There are three Gothic stained glass double-hung windows on the north and east frame elevations. In each of the north and east gable ends there is a large stained glass window with quatrefoil design. Three double-hung windows flank the northeast door. These have simple wooden pediments.

At the northeast corner of the north elevation there is a bell tower with decorative woodwork. The six-sided spire roof has four cross gables on the north, south, east, and west elevations. A large metal bell hangs in the tower. There is one interior stove chimney on the north elevation of the east wing. The church has an intersecting gable roof with slate covering. The gable roof over the cinderblock wing is parallel to the gable roof of the frame section and is covered by asbestos shingles.

The northeast door opens into a small room. A door on the east wall leads into the church. A second door, on the north wall, leads into a transept southeast of the nave. The floors have been covered by tile. The walls are stuccoed; there is tongue and groove wainscoting and ceiling. In the south altar wall, there is an interior round stained glass window with quatrefoil design which corresponds to the north and east windows. Between the transept and the nave there is a large rectangular opening surmounted by six transom lights.

There are two seating sections divided by a central aisle. The pews are constructed of golden oak and there is a very simple paneled golden oak altar. Behind the altar on the east side is the choir area and organ. There are three modern hanging lights.

Southwest of the church there is a modern two and a half story brick building which appears to be a church school.

STATEMENT OF SIGNIFICANCE

This church building although only 65 years old, is the seat of a congregation that has had continuous existence since 1801. The present building was constructed in 1914 to replace the original church which was built nearby about 1801. Samuel Beall and Edward Owen had in 1801 donated the 75 perches on the west corner of Emory Lane and Cashell Road to trustees Daniel, Ely and Enoch Beall, Nathan Holland, Jr., and Stephen Shaw.¹ A small, frame structure of simple, plain style was erected and named Emory Methodist Church, South. Contributed furnishings were handmade.

The names of the builder and the first minister have not been discovered. However, the Baltimore Conference, Methodist Church, South, reported a few relevant items in the mid-1800s. In 1868 the church had a membership of 22. It was part of the Rockville Circuit in 1876 which also included Goshen, Brookeville, Rockville, Potomac Chapel, Concord, Gaithersburg and Barnesville besides Emory. In 1884 the Circuit was divided leaving Emory with Rockville, Goshen and Brookeville. About 1891 another division closed Brookeville, and the combined church was called Goshen-Emory.

On November 4, 1914, the cornerstone was laid for the present church. Calvin Bready, Sr. was in charge of the construction. The land on which it stood was transferred in 1915, amounting to 1 3/4 acres, by grantors John P. Ray, Jr., Annie I. Ray, his wife, and Caroline E. Murphy.² Rev. Frank Neel was the first pastor to serve at this location.

The old church, at the intersection of Cashell Road and Emory Lane, was converted into a private residence, and bears no resemblance to its original appearance.

In the late 1940s an addition was attached behind the church to use as a social hall and Sunday school. Shortly thereafter the pulpit was remodeled and the choir loft construction begun, which was completed in 1952.

In 1947 the original corporation papers were amended, changing the name to Oakdale Emory Methodist Episcopal Church.³

In 1968 the name was changed again to the current one. Church membership has grown through the years, from 22 in 1868 to 459 in 1974.⁴

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is an attractive, shingle-style, country church built in 1914. There are narrow clapboards on the lower half of the building, and dark green, patterned shingles above this level. The tall, thin, stained-glass windows are topped with recessed, triangular panels, and molded architraves encase the windows and panels. The open belfry is supported by posts that feature bracketed cornices, and the octagonal steeple, like the main church roof, is covered with slate.





IMPLEMENTATION

Once designated on the Master Plan for Historic Preservation, any substantial changes to the exterior of a resource or its environmental setting must be reviewed by the Historic Preservation Commission and a historic area work permit issued. The Ordinance also empowers the County's Department of Environmental Protection and the Historic Preservation Commission to prevent the demolition of historic buildings through neglect.

It is the intent of the Master Plan and Ordinance to provide a rational system for evaluating, protecting and enhancing Montgomery County's heritage for the benefit of present and future residents. The accompanying challenge is to weave protection for this heritage into the County's planning program so as to maximize community support for preservation and minimize infringement on private property rights.

THE AMENDMENT

The purpose of this Preliminary Draft Amendment is to consider the Montgomery County Historic Preservation Commission's recommendations that the following sites be designated on the Master Plan for Historic Preservation and protected under the County's Historic Preservation Ordinance, Chapter 24A of the Montgomery County Code. A copy of the Ordinance is provided in Appendix B of this document.

(NOTE: Unless otherwise specified in the Preservation Commission's nomination, the recommended environmental setting for each site is the entire parcel on which the resource is located as of the date it is designated on the Master Plan as defined in Section 24A-2 of the County's Preservation Ordinance. Where additional buildings of historical or architectural importance are associated with a site, these buildings are noted in the nomination as being part of the recommended setting.)

<u>Atlas #</u>	<u>Site</u>	<u>Location</u>
15/55	Spencer/Carr House	2420 Spencerville

- Dating from 1855 with a rear section added in the 1870's, this three-story house is distinguished by three over three windows on the third floor and a one-story porch with bracketed pillars on the front facade.
- Significant as an example of the "Spencerville style", a local style characterized by a special grouping of architectural detail most notably half windows on the third story extending into the boxed cornice and roof line.

23/98-4 St. John's Episcopal Church 3427 Olney-Laytonsville Rd.

- One and one-half story wooden frame church dating from 1842 with fieldstone foundation, stucco exterior walls, stained glass lancet windows, and featuring a three-story bell tower which was added to the church in 1910.
- Oldest Episcopal Church building in continuous use in Montgomery County and one of only two structures remaining of Olney's historic crossroads.
- The recommended setting includes the cemetery associated with the church.

23/103 John D. Berry House 17201 Palomino Court

- Built between 1866 and 1876 this two and one-half story frame farmhouse consists of four distinct wings and is illustrative of the evolution of rural vernacular architecture in Montgomery County.

The recommended setting incorporates a number of significant outbuildings including a stone carriage house, a frame bank barn and other smaller outbuildings.

23/106 Oakdale Emory United Methodist Church Georgia Avenue and Emory Grove Rd.

- Constructed in 1914 -- One and one-half story frame church exhibiting elements of Shingle style architecture including wooden shingles on the gable ends which feature large, stained glass windows in a quatrefoil designs and a bell tower with six sided, spire roof.
- Seat of a congregation in continuous existence since 1801, the church is an unusual example of Shingle style architecture and important as a last vestige of the historic Oakdale community.
- The two parsonage buildings on the church property are excluded from preservation as part of the setting.

23/107-1 Hyatt/Jones House 16644 Georgia Avenue

- Circa 1870's -- two-story frame house important as a superb and well maintained example of Gothic Revival architecture typical of that constructed in Montgomery County from the mid-nineteenth through the early twentieth centuries.
- Historically, important as a last vestige of the historic community of Oakdale.
