DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building is of frame construction, 1½ stories high over a low basement, three bays wide by two deep. A half-hip porch with turned posts spans the principal (northwest) facade; double 6/1 sash windows flank the central entrance. The ridge of the gable roof runs parallel to this facade; a shed dormer, centered in the front slope of the roof, lights the half-story. The northeast gable facade has two 6/1 sash windows on the ground floor, and a single 6/1 window at the peak. There is a shed addition at the rear. Present siding is asbestos shingle. Exposed rafter ends enhance the eaves.
