9. Description: This eight bay by three bay, two and a half story house is at the end of a long private road and faces southeast. The central three bay, two and a half story section is flanked to the northeast by a three bay, two story wing and to the southwest by a two bay, one story wing. The house is constructed of random-cut ashlar blocks. There is a gabled porch roof supported by two gigantic wooden columns on the southeast elevation. There are six-over-nine double hung windows at the first level, southeast elevation, center section. Remaining windows are six-over-six double hung and are flanked by white wooden louvered shutters. The center section has a hipped roof with green asbestos shingles. The northeast and southwest wings have slate covered gable roofs.
10. Significance: This elegant house is associated with the Dodge/Davidson families of Georgetown and with Potomac's farming era, as well as being the home of Lilly Moore Stone, active in County civic affairs. Charles Dodge and his wife, Eliza Davidson, built Glenmore in 1870. Both the Dodges and Davidsons were prominent Georgetown families. Charles Dodge served as Army paymaster and as collector of customs of the District of Columbia. In 1879 the house and 118 acres were purchased by John D. W. Moore, and became known as Glenmore Farms. Glenmore was inherited by his daughter, Lilly Moore Stone, wife of Frank Pelham Stone. The couple did not live at Glenmore from 1909 to 1940, but operated it as a farm and boarded horses there. Glenmore Springs natural mineral water was bottled and sold in the Washington area in the early 20th c. Lilly Moore Stone opened Stoneyhurst Quarries on River Road in 1921 and personally ran the quarry operations for 30 years. Active in civic organizations, she assembled a group of people at Glenmore in 1944 to form the Montgomery County Historical Society. She was also involved in designing the first County flag. **DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This eight bay by three bay, two and a half story house is at the end of a long private road and faces southeast.

The central three bay, two and a half story section is flanked to the northeast by a three bay two story wing and to the southwest by a two bay one story wing. The house is constructed of irregularly sized ashlar blocks. On the southeast elevation, the gabled porch roof is supported by two gigantic wooden columns. The southeast door is wooden paneled and has applied carved wooden shell decorations. At the northeast elevation eight stone steps, flanked by a wrought iron hand rail, ascend to the stoop where a glass and wooden paneled door opens into the kitchen.

The house has six over nine double hung windows at the first level of the southeast elevation, center section. The remaining windows are six over six double hung and are flanked by white wooden louvered shutters.

The center section of the house has a hipped roof with green asbestos shingles and the northeast and southwest wings have slate covered gable roofs. The cornice line is boxed. There are three interior chimneys: two above the center section and one above the southeast wing.

The southeast door opens into a small hall. To the northeast is a large powder room and to the southwest is the study, beyond the study, is the southwest two bay wing, in the library. Northwest of the study is the drawing room. Immediately northeast of this room is the dining room. A narrow hallway, on a northeast-southwest axis leads from the central hall to the northeast wing, where the kitchen and pantry are located. An open string, single run staircase ascends along the northwest wall of this hallway. The staircase has a turned newel post and balusters. There is a closed string and double run stairway at the east corner of the kitchen located behind a wooden paneled door.

The floors are narrow hardwood. There are sixteen foot ceilings in the center section. The walls and ceilings are plaster over lath. There are simple carved moldings and wooden paneled doors. The dining room has a crystal chandelier.

**STATEMENT OF SIGNIFICANCE**

According to the tax records, Glenmore was built in 1870 by Charles Dodge and his wife Eliza Davidson who was one of the heirs of Lewis G. Davidson. Both the Dodges and Davidsons were prominent Georgetown families. Charles Dodge was a pay master for the Army. For a time he was interested in gold mining in Maryland. In 1889 he succeeded his brother Frank as collector of customs of the District of Columbia.

In 1879 the house and 118½ acres were purchased by John D.W. Moore and became known as Glenmore Farms.<sup>1</sup> Glenmore was inherited by a daughter of John Moore, Lilly Moore Stone, wife of Frank Pelham Stone. Although the Stones did not live at Glenmore from 1909 to about 1940, it was operated as a farm and a place for D.C. residents to board horses. Glenmore Springs natural mineral water, advertised for its purity and curative powers, was bottled and sold in the Washington area early in the twentieth century.

Lilly Moore Stone opened Stoneyhurst Quarries on River Road soon after the death of her husband in 1921. She personally ran the quarry operations for 30 years. In addition to her activities as a business woman, Mrs. Stone was active in many civic and fraternal organizations. It was at Glenmore on June 29, 1944 that a group of people assembled by Mrs. Stone founded the Montgomery County Historical Society. Mrs. Stone was also instrumental in designing the first Montgomery County flag.<sup>2</sup> Lillystone Drive was named for her.

The house at Glenmore was extensively remodeled in 1937. A small wing was added on the left to balance the kitchen wing on the right, stone veneer was added to the entire house, and the one-story front porch was replaced by an impressive entry with two-story columns.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The house is a two-story, frame structure covered with a quarried stone veneer in the 1930's. It has a low hipped-roof with twin brick chimneys rising near the center. There are three bays on all sides and the central entrance is in the south facade. The two-story columns support a small pediment over the entrance but these were 20th century additions. Windows are all 6/6 double-hung and there is an early two-story wing attached to the east. The interior is almost completely intact from the date of original construction in 1864.


