9. Description

This is an unusual house, built of rammed earth and coursed stone set in forms that laid a thick foundation but tapered as they reached the roofline. Two sections were built in this fashion -- the (north) 2-story, main house, and the 1-story wing in the middle. The main section is Federal-style, with three bays; one of the two windows on the first floor has settled almost a foot below the other. Windows are 6-over-6, double-hung, and there are moldings over the window heads. A large, brick chimney rises 2 stories on the exterior north wall. The house presents a uniform appearance, with painted stucco surface and tin roof.

10. Significance

The Gaegler house has led a varied existence, beginning as the showplace of the Gaegler farmstead, a family intricately involved in the life of the vanished community of Montrose, and later serving a company which manufactured vaccines and antitoxins. It was built between 1856 and 1865 by Rudolph Gaegler. Around 1870 his daughter Mary and her husband Francis Heley began the Montrose Store, later becoming postmasters. She sold the property in 1914 to the National Vaccine and Antitoxin Institute, which used the 53 acres for an experimental farm; the Institute manufactured and sold vaccines, antitoxin, and other biological products used in the treatment of farm animals. The company went out of business in 1920, partly due to its practice of guaranteeing effective serum to its nationwide dealers, and the property was sold at public auction the following year. The land has been resold several times since, each time losing more of its acreage. The present owner, Albert Gotch, bought the house and two acres in 1944.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a most unusual house. At first glance it appears to be a stucco-covered, Federal-style building of brick or stone. However, it was built of rammed earth and coursed stone set in forms that laid a thick foundation but tapered as they reached the roofline. Technically, it is a masonry house.

Two sections were built in this fashion—the (north) two-story, main house, and the one-story wing in the middle. Allegedly, the earliest section was a one-story log cabin that stood where the present, twentieth-century, south wing is now. Joined to this modern wing is another one and a half-story, two-bay part facing east. A hood-type portico covers the entrance in the northernmost bay of this middle section. Attached to this is a two-story, Federal-style house of three bays. While the second story here has three windows, there are only two windows on the first floor, the northeast corner being a blank wall. Perhaps there was never an opening here because the earth walls could not support the weight of the second story. (One of the two windows on this facade has settled almost a foot below the other.)

Windows are six-over-six, double hung, and there are moldings over the window heads. A large, brick chimney rises two stories on the exterior north wall.

The house presents a uniform appearance with matching shutters, a painted stucco surface, and an older tin roof in each section. Inside, the floors and moldings are of an early period and, in the attic, the round chestnut rafters are joined to a heavy ridge pole.

STATEMENT OF SIGNIFICANCE

The Gaegler House is a building unusual in its historical association, having performed a purely domestic function common to all family dwellings, and yet, at one time, participated in a highly technical commercial venture. For over 100 years the building has led a full and varied existence, beginning as the showplace of the Gaegler farmstead, a family intricately involved in the life of the vanished community of Montrose, and later serving as a major component of a company engaged in the manufacture and distribution of veterinary vaccines and antitoxins. Today it stands amidst modern architectural complexes as a reminder of a past heritage.

The Gaegler house was built between 1856 and 1865 by Rudolph Gaegler on his 72-acre farm. Around 1870 Gaegler's daughter, Mary, and her husband Francis Heley, established the "Montrose Store" on a one-acre parcel of the farm, at the intersection of current Old Georgetown Road and Route 355. Francis Heley, bought the entire plot from the remaining Gaegler heirs. The property then consisted of a five-room stone house, barn, stable, "grainary," and poultry house, completely fenced.

In 1914, Mary Heley sold the property to the National Vaccine and Antitoxin Institute, owned by Dwight T. Scott. The Institute was one of only eighty-one companies licensed by the U.S. Department of Agriculture for interstate shipment of veterinarian medicine under the Virus-serum-toxin act of 1915, and one of the first companies licensed. The Institute manufactured and sold vaccines, antitoxin, and other biological products used in the treatment of farm animals.

The experimental farm at Montrose was referred to as the "National Vaccine Station" and comprised 53 acres including the stone house, Montrose Store, a frame house with six rooms and bath, five stables, a silo, a frame corn house, and a garage and pump house. (See quoted description on page 3 of historical report.)

The NVAI founded a practice of guaranteeing effective serum to their nationwide dealers, and replacing outdated medicine. This practice proved impossible at the time, and led to the dissolution of the corporation.

Scott resigned in 1920, leaving the company with a debt of over \$70,000. A trust company took over the business at a loss of \$1,500 a month. The property was sold at public auction to Leonard C. Nicholson for \$30,000 in 1921.

In 1922, Nicholson sold the entire property to Adam Cokinos. In 1924, Cokinos sold eight acres including the Gaegler House to Milo G. Coplen, who sold the house and two acres to Thomas Lee Smith in 1941. The present owner Albert Gotch, bought the parcel in 1944.
