Description

Two and a half story brick house with a one story frame addition at rear. Single flush chimney at each end, five-bay facade, center entrance, gable roof, Georgian style. One-room deep plan, central stair hall, winding stair, single-hung windows with thin, old glass. Log first floor framing, quarter-round attic windows in gable ends.

10. Significance

One of the few 18th century buildings in urban Montgomery County. Home of Henry Lazenby II. He and his father, Robert, were early developers of this area. House has many characteristics of 18th century Georgian architecture: gardens good example of 18th century baroque planning.

Henry Lazenby II was a descendant of a prominent old Maryland family; born in 1721, he enlisted in the Prince George's County Militia, and later built Milimar on 100 acres near his father's plantation.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

"Milimar" is located on the south side of Randolph Road at #410 in Silver Spring, Maryland.

The house is noteworthy as an example of an early "middle" class home. It is definitely not an elaborate mansion, but it is much more than the log houses which were still the most common dwelling in this part of Maryland in the eighteenth century. The front facade is Georgian in style, with an essentially straightforward and symmetrical simplicity. There are muted but unmistakable touches of decoration, especially in the three rows of brick offset in an ornamental pattern in the dentil (cornice) under the eaves; in the over-window rows of vertical brick; and in the quarter-round windows on either side of the chimney at attic level in the south gable, which have an elaborate pattern of pane dividers (almost identical to those at Sotterley plantation in Southern Maryland).

The older portion of "Milimar" is a two-and-one-half-story brick building with gable roof. A one-story frame addition was erected across the rear (east facade) of the house at a later date. The front (west) facade is five bays long with the entrance in the center bay. This facade is constructed of Flemish bond brick, while the rear and sides are of common bond.

There is a single flush chimney in each gable end, both with "drip courses." A larger chimney in the older south end has three flues, including one from a large cellar fireplace.

The interior of the old brick portion of the house is one room deep, measuring sixteen feet on the exterior. On the first floor, there is a center hall flanked by two rooms. There are three bedrooms and a bath off a narrow (27") hall on the second floor. The newer addition on the rear has a garage on the cellar level and a kitchen, den, and bathroom on the first floor level.

Significant interior features include the center hall stairway, which turns a 90° angle at mid-height with "pie-steps" (no landing); it has an old handrail which includes a five-foot section with two natural "knee" curves in it, and hand-turned newel posts fastened to the rails with wooden pegs. The fireplaces in master bedroom and dining room are faced with tiles made from local soapstone with an unusual design. The interior doors are mainly of hand-made panels, fastened with wooden pegs. All windows in the old brick portion are single-hung and some panes are of very thin old glass.

The first-floor framing is partly of sawn timber and partly of log. The original second-floor flooring is of random-width hard yellow pine. In the cellar is a large fireplace, once

used for cooking; it had been bricked up with crane and hooks still inside.

Outside, there is an elevated brick terrace ten feet wide across the front and south ends of the house. A noteworthy feature is the "L"-shaped double row of boxwood that runs along the edge of the terrace. The two hedge-rows are about fifteen feet apart and form a protected "dry moat" area between them. They are over ten feet high in some places and average five to six feet high and several feet wide.

At the entrance to the property stands an old field-stone gate structure consisting of two seven feet high stone gateposts supporting heavy wooden gates hung from massive iron hinges. The gate is flanked by a curving ivy-covered stone wall and old boxwood plantings. One large clump of this boxwood is fifteen feet tall and equally as wide.

There is a double line of tall spruces forming a wide wind-break across the northern end of "Milimar." The house is oriented by the compass, and the front faces due west for maximum sun heating.

STATEMENT OF SIGNIFICANCE

"Milimar" is believed to have been built by Henry Lazenby II, a descendant of a family which came to Maryland at the very beginning of the eighteenth century (1701) with a large land grant from Charles Calvert, the Third Lord Baltimore. The Lazenby family has been prominent in Maryland history from these early times until the present day. The first Henry Lazenby in America was High Sheriff of Anne Arundel County from 1720 until his death in 1723. His wife Margaret was an aunt of the then-governor of Maryland, another Charles Calvert.

Henry Lazenby II, the namesake of the above-mentioned High Sheriff, was the son of Robert Lazenby, one of the early settlers (before 1720) in the Layhill area of what is now the southeastern corner of Montgomery County, Maryland. In 1723, Robert bought a 217-acre tract called "Wolf's Den" from William Beall. Robert's younger son, Henry Lazenby II, was born in 1721. He enlisted in the Prince George's County militia in 1748. In 1760, he bought a 100-acre tract called "Girl's Gift" near his father's plantation. A family genealogy records that he built, or at least began to build a house in the same year.

"Milimar" is one of the few extant eighteenth-century buildings in urban Montgomery County. Architecturally, it represents a style and a way of life which was present in the early history of the county, but which is now rapidly disappearing.

The boxwood hedges are important surviving examples of early landscape design.



Tax Map JR41




