9. Description: The battery is atop a hill overlooking Little Falls Branch & is constructed in a "C" shape facing north. It contained 6 platforms for field guns in embrasure; ramparts or trenches extended westward toward the creek and eastward to Fort Mansfield.
 Today, the battery & approaches are overgrown with trees and brush. The sharp outlines of the battery have been rounded by time. There appear to be 6 cuts for embrasures in the ramparts, and the remains of the terrepleins are visible.
10. Significance: One of President Lincoln's many concerns during the first months of the Civil War was that the Rebels would capture Washington. To fortify the capital, a series of forts, batteries and entrenchments were constructed around the city; this defensive perimeter eventually totaled 34 miles in circumference.
 Battery Bailey was named for Col. Guilford D. Bailey, killed in the battle at Fair Oaks in 1862.
 Battery Bailey was left unmanned, as it was difficult to assault through the narrow creek and valley. There was no action here during the Civil War.
 Battery Bailey is the only Civil War fortification remaining in Montgomery County.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The earthworks were called Battery Bailey. The battery is on top of a hill overlooking Powder Mill Branch (now called Little Falls Branch) and is constructed in a "C" shape facing north. The battery is listed as being unarmed, being one of the 93 unarmed batteries in the 34 mile circle of forts and batteries that surrounded Washington. The battery was located halfway between Fort Sumner and Fort Mansfield. Ramparts or trenches extended westward toward the creek and eastward to Fort Mansfield. The battery contained six platforms for field guns in embrasure. There were no guns in barbette.

The battery and approaches are overgrown with trees and brush. The sharp outlines of the battery have been rounded by time. There appear to be six cuts for embrasures in the ramparts although center embrasures are difficult to make out. The remains of the terrepleins are visible although they are not all intact. The remains of the platforms cannot be seen. There is a raised section in the center of the fort which I could not identify. The location was a good one in that it is on the highest hill and must have had a good field of fire.

STATEMENT OF SIGNIFICANCE

One of Lincoln's many concerns during the first months of the Civil War was that the Rebels would march upon and capture Washington. To fortify Washington, a series of forts, batteries and entrenchments were constructed around the city. This defensive perimeter eventually totaled thirty-four miles in circumference.

Battery Bailey was named for Col. Guilford D. Bailey,¹ attached to the Fourth Corps, Second Division, the latter under command of Brig. Gen. Silas Casey. Col. Bailey was Casey's Chief of Artillery during the battle at Fair Oaks, May 31, 1862. He was shot from his horse with a bullet through his head while ordering guns of Battery A, 1st New York Artillery stationed in the redoubt off the Williamsburg Stage Road to be spiked. The redoubt was being overrun by Confederate Brig. Gen. Main's brigade.²

Battery Bailey was left unmanned, as it was difficult to assault through the narrow creek and valley. There was no action at Battery Bailey during the Civil War.

Many of these fortifications have been taken down to make way for housing and roads. Although some sites are preserved in the District of Columbia and Virginia (Forts Stevens, Ward, Marcy), none are preserved in Montgomery County. In fact, only a small segment of the defensive perimeter was in the County. It extended from the Potomac River just above the Defense Mapping Agency Topographic Center across Little Falls Parkway to River Road at Western Avenue. Forts Sumner, Mansfield and Simmons and Batteries Alexander and Benson are gone. The only remaining site is Battery Bailey. This battery should be reconstructed and preserved as part of Montgomery County's contribution to the defense of the nation's Capitol.








VIEW UP HILL IN A SOUTHWARD DIRECTION.




VARIOUS SITES OF THE BATTERY






VARIOUS SHOTS OF THE BATTERY

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The remains are located in a wooded bluff overlooking Little Falls Branch (near the Westmoreland Hills Recreation Center.) The earthworks are badly worn down, and the trampled earth is bare. However, a ring of shallow trenches can be discerned. It is hoped that now that the Parks Dept. is aware of this site, it will be stabilized and preserved.

According to a native of this area, an old farmhouse of Civil War period stood here at the time of Park acquisition.

STATEMENT OF SIGNIFICANCE

This is the last remaining vestige of Washington's Civil War defenses in Mont. Co. Part of a ring of connected forts and earthworks, constructed between Nov. and Dec. of 1862. The nearby Milton-Loughborough House was occupied by Union soldiers during the Civil War, although its owners served in the Confederacy.

NOTE: Digging of any kind on these lands is strictly forbidden! The site is protected by the Maryland Antiquities Act (besides which the fort was unarmed, and has been landscaped and stripped clean of any possible artifacts years ago.)

THE DEFENSES OF WASHINGTON

Located in Montgomery County During the Civil War
by Roger S. Cohen, Jr.

Among the casualties of the March of Progress have been the defenses of Washington constructed during the Civil War. Except in a few cases, almost all of the 161 forts and batteries as well as 20 miles of rifle trenches have been erased by the expansion of the Washington Metropolitan Area. Only a small portion of them were located in Montgomery County and those only because the topography of the western portion of the District of Columbia made it necessary. The accompanying map shows the location of these defensive works overlaid on a modern map of the area.

The first defenses of Washington were built as the result of a resolution of the U. S. House of Representatives on July 8, 1861. This resolution directed the War Department to survey and erect forts at important points on the approaches to Washington on both sides of the Potomac River. The Corps of Engineers of the U. S. Army had already surveyed in May and June, 1861; therefore, work was started immediately. (1)

In July, 1861, three forts were built in Montgomery County, namely Forts Ripley, Alexander and Franklin. They were located northwest of the Maryland approach to Chain Bridge in order to protect both the bridge and the Receiving Reservoir of the Washington water system. (1) (See accompanying map)





