Building 021 is located near Sellman Road and was constructed in 1930s from two existing cottages. USDA used the frame dwelling for employee housing. When the building was surveyed in 1996, it was not assessed for its potential as a contributing resource to a historic district. The USDA has now completed its survey of the entire BARC facility. Their consultant determined that the 6582 acres of BARC are eligible. The Trust concurred with this determination. Building 021 is a contributing resource to the BARC Historic District.

Building 021 is located in the North Farm area of the Beltsville Agricultural Research Center (BARC), where the Bureau of Plant Industry operations were established in the 1930s. The house was constructed in the early 1930s by the U.S. Department of Agriculture for use as a laborer's cottage, one of a number erected by the government to house employees at the experimental farm. It was created by combining two extant early twentieth-century three-room cottages that had once formed a part of the nearby Sellman property. Unlike many of the other residences, which were named for the employee who first occupied them, Building 021 was never associated with a family name -- an indication of the transitory nature of the occupants and the use of the house as temporary quarters for many.

Overview

Building 021 is a small one-story house characterized by a series of gabled forms. Located on the North Farm of the Beltsville Agricultural Research Center, the house sits close to Sellman Road. It was created in the early 1930s out of two existing three-room cottages that had formed a part of the Sellman House property.

Exterior Description

This residence comprises two side-gabled blocks, joined at the southeast corner. The principal (or north) facade consists of a one-story, side-gable block. A shed-roof porch projects over the eastern half of the elevation, sheltering the main entrance and a recently installed one-over-one window. The original windows in this section of the house are two-over-two sash.

The rear (or south) elevation is composed of three elements: a side-gable block on the east, a front-gable block on the west, and a shed-roofed bridge between the two. All three of these blocks run flush with one another to create a single elevation. The central bridge features a row of casement windows. Adjacent to these windows, in the side-gabled block, is a screen door covered by a small projecting shed-roof porch supported by two posts. There are no other windows on this elevation. In the front-gabled block at the western end of the elevation, there is a small vent in the apex of the gable.

The east elevation consists of two, staggered, front-gable blocks. The smaller gabled block that comprises part of the rear elevation projects forward. There are two six-over-six windows and a small vent in the apex of the gable. An exterior chimney stands near the junction of the two sections. The recessed main-block gable that forms the northernmost part of this eastern elevation features a single two-over-two window and a small vent in the apex of the gable.

The west elevation consists of a front-gable block that adjoins a slightly recessed side-gable block, resulting in a cross-gable effect. The front-gable block features a single window and a small vent in the apex of the gable. The side-gable block also features a single window.

Building 021 is covered in aluminum siding; the roof has been replaced, as have some but not all of the windows. When the house was erected, there were no amenities, such as power, heat, or water. It is not known when these amenities were added.

Interior Description

The interior of the house is characterized by its circular circulation pattern; there are no halls, and each room opens onto the next. The front door opens directly onto a square, carpeted living room with two windows. The ceiling of the room is delineated into sections by wooden mullions. Wooden brackets also ring the room at a high wainscot level. There are no other particularly distinctive interior

features. The windows and doors have simple wood surrounds. To the west of this room is a bedroom; to the south is the kitchen. The bedroom has several closets and features two windows. Adjoining the bedroom is another room, which connects to the kitchen.

The kitchen is illuminated by a row of four casement windows, located above the bank of cupboards and the sink. There is a rear door, with panelling in the lower half and a window in the upper half located to the east of the bank of cabinets. To the east, off of the kitchen, is the small gabled extension that contains the furnace room and a bathroom.

Overview

Building 021 was one of several small laborer's cottages on the North Farm parcel of the Beltsville Agricultural Research Center in the 1930s, when the Department of Agriculture was developing the Bureau of Plant Industry's presence at the station. The building was constructed by combining two small, early twentieth-century wood-frame houses that stood on the Sellman property prior to the government's acquisition of the land.

Building 021: A Government Laborer's Cottage

Building 021 was constructed out of two three-room frame dwellings that had existed on the Sellman House property prior to BARC's acquisition of the land. Its conversion was for a new use as an inexpensive government laborer's house. The two frame buildings comprising the new, larger residence had originally stood some "1000 feet N.E. of barn."¹ An inventory of residences listed the house as being acquired in 1934 with monies from Public Works Administration, the Works Progress Administration, and Bureau of Plant Industry funds.² It was located near the vineyards along the northern boundary of the North Farm. The house was occupied in 1935 by William T. Edwards, a farm laborer who earned \$70 a month. For rent, \$5 a month was deducted from Edwards' salary.³

Building 021 was one of two that was constructed on the property by the government. It was not equipped with any amenities, such as a furnace, water, or power. Already in the residence inventory memorandum of June 14, 1935, it was listed as "not in good repair, no modern conveniences, or furnace; value of same \$900." In 1938, when a number of improvements were undertaken on other residences, no work was done on Building 021.

It seems likely that the house had a frequent turnover of residents. Although Edwards is listed as the occupant in 1935, a subsequent list of residents on the North Farm does not contain his name. It does, however, list three other men -- single, with no family -- who are not immediately connected with any

single residence: John W. Hopper, R. Baxter Herbert, and George M. Banner. It seems possible that one of these three men was then living in Building 021.⁴

The house is currently unoccupied.






