DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a large dairy barn, of the early 1900's, that has been remodeled into the rental office of an apartment complex. It is a long frame building, with a large gambrel roof that ends in a "kick" at the eaves. Roof has two large metal vents centered on the ridge. New board and batten siding, with wooden shingles covering the gable-ends.
