Building Name: The Quander House

Location: 4512 Rhode Island Avenue (U.S. Route 1)

Description:

The Quander House is a square frame bungalow with a hipped pyramidal roof, set high on a rock-faced cement block foundation, situated on a small town lot fronting on Rhode Island Avenue. The three-bay east facade has a central entrance with a rectangular transom, flanked by 2/2 double-hung sash windows. The entrance is sheltered by a one-bay hipped roof porch set high on a cement block base. The metal trellis porch posts and balustrade are modern alterations. The house is covered with white, lapped aluminum siding and roofed with asphalt shingle. The boxed cornice has overhanging eaves. The north facade was formerly the main facade. The house was turned a quarter turn due to the extension of Rhode Island Avenue, in 1929. The second bay entrance is surmounted by a transom. The second and third bay are sheltered by a hipped roof screened porch on a high cement block base.

Significance:

The Quander House is significant as one of the earliest houses in North Brentwood, and for its connection to the Hawkins and Quander families. North Brentwood was developed on a part of a 100 acre tract acquired in the early 1890's by a land syndicate called the Holladay Company. Captain Wallace A. Bartlett, a company partner, had served in the Civil War commanding the 19th Infantry of U.S. Colored Troops. In subdividing North Brentwood, it was Bartlett's desire that black families occupy the tract. Lot 6, Block 20, fronting on Railroad Avenue, was acquired from Barlett by Wesley L. and Frances Carter in 1903. The house was taken by the State Roads Commission in the late 1920's. After the extension of Rhode Island Avenue from the District of Columbia, the house was left on a smaller lot, with its eastern end in the road right-of-way. The house was sold to Emma F. Hawkins by the State Roads Commission in 1930, with the condition that the house be moved at the buyer's expense. Hawkins, widow of North Brentwood's first mayor, Jeremiah Hawkins, owned the house for the next forty years. It was occupied by her adopted son, Vincent Quander, who acquired the property in 1970 and continues to reside there.

The Quander House is a square frame bungalow with a hipped pyramidal roof, set high on a rock-faced cement block foundation. It is situated on a small town lot fronting on the west side of Rhode Island Avenue.

The three-bay east (main) facade has a central entrance with a rectangular transom, flanked by 2/2 double-hung sash windows. The entrance is sheltered by a one-bay hipped roof porch set high on a cement block base, reached by a flight of cement stairs. The metal trellis porch posts and balustrade are modern alterations.

The Quander house is covered with white, lapped aluminum siding. The windows have wide aluminum surrounds. The roof is covered with asphalt shingle. The boxed cornice has overhanging eaves. The high rock-faced cement block foundation has boarded-over window openings.

The four bay north facade has formerly the main facade. The house was moved back and turned a quarter turn due to the extension of Rhode Island Avenue, in 1929. The second bay entrance is surmounted by a transom. The second and third bay are sheltered by a hipped roof screened porch on a high cement block base. An exterior entrance to the basement is beneath the porch. Windows on the facade are 2/2 sash.

The south facade is entirely covered by a shed roof, two-by-one bay addition set on the same foundation as the main block. The addition is flush with the east and west elevation of the main block and the siding is uninterrupted in covering the whole.

The west (rear) elevation is three bays on the main block and one bay on the addition. The first bay of the main block projects slightly and is surmounted by an enclosed pediment with a square window.

The interior doors and windows have banded surrounds with a bull's-eye corner blocks. The doorways are surmounted by transoms.

Prepare both a summary paragraph of significance and a general statement of history and support.

The Quander House is significant as one of the earliest houses in the incorporated town of North Brentwood. The house was probably built shortly after the area was platted as "Holladay Company's Addition to Highlands," in 1905. The house is also significant for its connection to the Hawkins and Quander families, who have been active leaders in North Brentwood and Prince George's County, since early in this century.

The Town of North Brentwood was developed on a part of a 100 acre tract acquired in the early 1890's by a land syndicate called the Holladay Company. The syndicate platted the areas which eventually became Brentwood, North Brentwood, Mt. Rainier and a southern section of Hyattsville.¹ Captain Wallace A. Bartlett, a company partner, had served in the Civil War commanding the 19th Infantry of U.S. Colored Troops, composed of Black men from Southern Maryland and the Eastern Shore. In subdividing the North Brentwood area, it was Captain Bartlett's desire that black families occupy the tract, in tribute to the soldiers who had served in his regiment.²

Lot 6, Block 20, fronting on Railroad Avenue, was acquired from Barlett by Wesley L. and Frances Carter in 1903.³ At that time, the Columbia and Maryland Railway, a trolley line, ran from downtown Washington past the Quander house, up to Hyattsville, on what was to become an extension of Rhode Island Avenue.⁴ North Brentwood then consisted of 15 homes, sheltering approximately 65 people.⁵

The Quander house was acquired by James and Ethel Randall Johnson in 1913.⁶ The Randall and Johnson families were some of the first black families living in North Brentwood.⁷ The Johnson's occupied the house until it was taken by the State Roads Commission in the late 1920's. After the extension and widening of Rhode Island Avenue from the District of Columbia, the Quander house was left on a smaller lot, with its eastern

end in the road right-of-way. The house was sold to Emma F. Hawkins by the State Roads Commission in 1930, with the condition that the house be moved at the buyer's expense.⁸ The house was turned one-quarter turn to the north, so that the east elevation became the north end, and the house was safely out of the right-of-way.⁹ Emma F. Hawkins, widow of North Brentwood's first mayor, Jeremiah Hawkins, owned the house for the next forty years. It was occupied during her ownership by her adopted son, Vincent Quander, who acquired the property in 1970 and continues to reside there.¹⁰


