Description

The Bellman House is a large, three-by-two bay, two-story frame dwelling with a cross-gable roofline and corner octagonal tower. The house is stucco-covered and has a wrap-around entry porch with Victorian detailing. It stands on a town lot, on a hill overlooking 33rd Street in Mt. Rainier. The three-bay east (main) facade is irregularly massed, due to the projecting octagonal tower at the southeast corner and a two-story semi-octagonal bay surmounted by a pediment in the northeast bay. The central entrance is surmounted by a narrow dentilled band, below a rectangular transom. The first story is sheltered by a hipped roof entrance porch which wraps around the south side of the building. The frame structure of the house is covered with beige stucco material scored to look like stone blocks. The house rests on a high concrete foundation covered with the same stucco material. The roof is covered with red shingle. There is a wide frieze, boxed crown-molded cornice and deeply overhanging eaves.

Significance

The Bellman House, dating to ca. 1905, is significant as a large Queen Anne house in the simplified style constructed in suburbs throughout the nation around the turn of the century. It is one of a cluster of large early twentieth dwellings with architectural styles recalling late nineteenth century Victorian domestic architecture, located in Mt. Rainier. Mt. Rainier developed as a streetcar suburb beginning with the platting of the Mt. Rainier subdivision in 1903. The house was constructed for Oscar and Bertha Bellman, originally from Hagerstown, Maryland in 1905. Bellman was founder and owner of the Bellman Heating Company in Washington D.C. The house was the home of members of the Bellman family for 56 years.

The Bellman House is a large, three-by-two bay, two-story frame dwelling with a cross-gable roofline and corner octagonal tower. The house is stucco-covered and has a wrap-around entry porch with Victorian detailing. It stands on a town lot, on a hill overlooking 33rd Street in Mt. Rainier, immediately to the east.

The three-bay east (main) facade is irregularly massed, due to the projecting octagonal tower at the southeast corner and a two-story semi-octagonal bay surmounted by a pediment as the northeast bay. The central entrance has a six-panel door with nine panes glazing the upper half. The door is surmounted by a narrow dentilled band, below a rectangular transom. The windows on first and second stories are 1/1 double-hung sash with narrow wood surrounds. The first story is sheltered by a hipped roof entrance porch which wraps around the south side of the building. The porch is set on a high parged concrete foundation and has a wooden floor, reached by a flight of six concrete steps. The turned and chamfered porch posts are arranged in pairs set on high stucco-covered concrete bases. The balustrade is a modern replacement metal balustrade. The posts support a roof with a plain frieze, and an overhanging boxed crown-molded cornice. There are foundation windows beneath the porch and a ground level entry to the basement beneath the southeast corner of the porch, reached by two steps down.

The tower is a full octagon at loft level. There is a 4/2 sash window in each face and it is surmounted by a pyramidal cap. The enclosed pediment above the northeast bay has a square 8/8 sash window and a wide crown-molded raking cornice.

The frame structure of the house is covered with beige stucco material scored to look like large blocks. The house rests on a high concrete foundation covered with the same stucco material. The roof is covered with red shingle. There is a wide frieze, boxed crown-molded cornice and deeply overhanging eaves.

The two-bay south elevation is sheltered by the east entrance porch which wraps around the crosses the entire facade. There is a one-story semi-octagonal west bay. There are four windows on the facade. It appears that there may have been more originally.

The one-bay north elevation has double windows at second and third story levels, centered on the facade. An interior chimney with a parged covering rises just west of the windows.

The three-bay west (rear) elevation has a steep hipped roofline. An entry to the kitchen is in the northwest bay. It is sheltered by a two-bay, two-story shed roof porch supported on metal posts. There is an entry to the porch on the second story.

The interior of the Bellman House has an "L" shaped central hallway, and a square plan, with two parlors flanking the hall at the front of the house and a dining room and kitchen at the rear. The parlors are irregularly shaped due to the projecting bays and octagonal tower.

Entry is into a central hall flanked by a parlor on each side. The parlors are reached through wide rectangular entryways with fixtures for curtain poles. There are no doors or pocket doors. The dark stained wood door and window surround have an inset panel with raised rectangular inner and outer bands, set on base blocks. Cornices are wide and plain with raised crown molding.

The entry hall runs west through the house and then turns at a right angle to the north. The closed-string stair raises along the west wall in this north section of the hall. It turns 90° at a landing lighted by a double 1/1 sash window, turns 90° once again and rises along an east wall to the second story. The balusters are turned, with upper and lower blocks. The square newel post has an applied floral design and is surmounted by a spherical knob. A doorway beneath the stair leads to the basement.

The flooring throughout the interior is original, of narrow uniform width boards. The high baseboard has an ogee cap. The dining room, at the southwest corner of the house, has a mantel centered on the south wall. The mantel is purely decorative, as there is no chimney behind it. It has a square hearth opening surmounted by oval an applied floral design centered in the frieze. Grooved brackets support the mantel shelf. There is a rectangular mirror in the over-mantel. The upper mantel shelf is supported by tapering ionic columns on base blocks, and is surmounted by a band of egg and dart molding. There is a built-in cupboard with glazed doors in the west wall of the room, between an entry to the kitchen and an entry to the stair hall.

There are 4 bedrooms on the second story, surrounding a rectangular central hall. The stair to the unfinished attic is enclosed behind a door off the second story hall. The attic has one finished room, in the octagonal tower. It has a far reaching view to the east, as the house is located on a high ridge.

The town lot upon which the house stands has a steeply sloping front yard. The house is reached by a long flight of concrete stairs up from the sidewalk. The rear yard is quite flat and has a large oak tree.

It is one of a cluster of large early twentieth dwellings with architectural styles recalling late nineteenth century Victorian domestic architecture, located in Mt. Rainier. Mt. Rainier developed as a streetcar suburb beginning with the platting of the Mt. Rainier subdivision in 1903. The house was constructed for Oscar and Bertha Bellman, originally from Hagerstown, Maryland in 1905. Bellman was founder and owner of the Bellman Heating Company in Washington D.C. The house was the home of members of the Bellman family for 56 years.

The Bellman House is constructed on Lot 8, Block 3 of the Mount Rainier Subdivision. Bertha O. Bellman purchased the lot from members of the real estate partnership which had platted the subdivision. Tax records indicate that the house was constructed at the time of purchase. It was constructed by Wesley Dayhoff, a building contractor who was also a native of Hagerstown, Maryland and was married to Bertha Bellman's half-sister. Dayhoff was responsible for a number of other houses in Mt. Rainier at that time.

A ca. 1921 photograph shows the Bellman house substantially as it is today, with the same stucco wall treatment and front porch resting on the projecting basement story. A driveway visible along the south side of the lot has since been filled in.

Oscar Bellman (1875-1937) was the founder of the Bellman Heating Company, which was involved in installing residential heating systems. The company offices were located on 5th Street Northwest, in downtown Washington. After Bellman's death in 1937 the business was assumed by three of Bellman's sons, Donald, Robert and Alfred.

Bertha Bellman lived on at the family residence with son Robert Bellman until her death in the late 1940's. Robert Bellman was involved with the family business and lived at the house until his death in 1961. At that time the property was sold out of the family.

The Bellman House is significant for its Queen Anne style detail, including an octagonal tower and semi-octagonal bays on the front and side elevations. It also retains double turned porch post. The interior of the house has the original wide wood Classical Revival style moldings around doors and windows which were very popular in the early twentieth century. Three of the door openings, into the parlors and dining room are wide and probably originally had curtain closures.

The stair with turned balusters and rectangular paneled newell, and the built-in cupboard in the dining room with glazed doors are outstanding features.

The Bellman house is significant as an example of the turn-of-the century suburban Queen Anne style. It stands out as one of the more elaborate dwellings in the streetcar suburb of Mt. Rainier. It also is significant as the home of the Bellmans, one of Mt. Rainier's early families, who were members of the community for 56 years.





HOUSE LOCATION


