DESCRIPTION

The Holland-Brown House at 4716 Riverdale Road (Lot 14, Block 41, Riverdale Park) is a two-story and attic, detached, frame dwelling with a rectangular plan, a rusticated concrete block foundation, and an asphalt-shingle, hip roof with overhanging eaves. In both plan and decoration, the house is a traditional, turn-of-the-century Foursquare. The exterior is simply-detailed; the foundation has been painted and the house is currently sheathed with white vinyl siding. With the exception of the windows in a modern rear porch, windows throughout are wood-frame, double-hung sash that are original to the house.

SIGNIFICANCE

The Holland-Brown House is a good example of the Foursquare, a nationally popular house form built in Riverdale and other Washington area suburbs throughout the early 20th century. The house is sited on the north side of Riverdale Road (originally Jefferson Street), about a block northwest of the Riversdale Mansion. Although the house is now aluminum-sided, its massing and fenestration are still intact, making the house a familiar visual feature of the streetscape along Riverdale Road. The house was built between mid 1909 and mid 1910 by Mamie E. and Christopher C. Holland, who sold the house soon after its completion. After several owners, the house was purchased in 1943 by Samuel T. Moore, Sr. whose family occupied 4716 Riverdale Road until 1978. The one-car, front-gable garage north of the house at the rear of the site was built by Moore in 1948.

The Holland-Brown House at 4716 Riverdale Road is a two-story and attic, detached frame dwelling with a rectangular plan, a rusticated concrete-block foundation and an asphalt-shingle hip roof with overhanging eaves. In both plan and decoration, the house is a traditional, turn-of-the-century American Foursquare. The house is sited on a single lot (60'x100') in the Town of Riverdale. The exterior is simply detailed; the foundation has been painted and the house is currently sheathed with white vinyl siding. Unless otherwise noted, windows throughout the house are original wood-frame, double-hung sash.

The house's main (south) facade is two bays wide. A hip-roof front porch, supported by wooden Doric columns, shelters the entire first story. The house's main entry, with its wood and glass "craftsman-style" door, is located in the facade's eastern bay. To the east of the door, placed high on the first story is a small, rectangular leaded-pane window. The western bay of the first story has a single, large, 1/1 window. At the second story, each bay is defined by an attached pair of 1/1 windows; each pair about the same size as the large first story window. The attic of the main facade contains a small hip-roof dormer with two square casement windows.

The west facade is composed of the two-bay, two-story main block and a one story shed-roof addition to the north. Each bay of the facade is fenestrated with single large 1/1 windows. Each bay of the main block is lighted by large 1/1 windows at the first and second story. A dormer, identical to the one on the main facade, lights the attic.

The north facade has a full-width shed-roof addition at the first story resting on a painted, poured-concrete foundation. The window size and configuration of the aluminum-sided addition are consistent with the main block although the addition is a recent one and represents the enclosure of a rear porch. The second story of the facade has three bays, each defined by a single 1/1 window; the window in the center bay is slightly smaller than the two that flank it.

The three-bay east facade contains a small rectangular leaded-pane window at the first story of the southernmost bay, identical to one on the main facade. The center bay contains a wood and glass door, at grade, that leads to the cellar. Above the cellar door and between the first and second stories, is a large double-hung window that lights the stair landing. At the second story, immediately north of this window is an identical double-hung window. Another window of the same configuration lights the first story of the north bay. North of the main block, the east facade of the enclosed shed-roof porch contains floor to ceiling multi-paned windows sheltered by a small, west-sloping shed roof.

Interior

The interior of the house retains much of its original plan. The entry/stair hall is located at the house's southeast corner, the parlor at the southwest, the large dining room north of the parlor and a large kitchen in the northwest corner. Connecting the kitchen and entry hall is a short hall with a storage closet and access to the cellar. Across the rear (north) end of the house is the enclosed porch, which the present owners use as a music room. With the addition, east of the music room and west of the enclosed kitchen porch is a bathroom. The present kitchen is an enlargement of the original with the removal of the service stair that connected the first and second floors.

A number of the interior's original decorative elements remain, although the house has been extensively updated by the present and previous owners. Throughout the house, there are original narrow-board wood floors, paneled oak doors and modestly-designed floor moldings and window and door surrounds with bull's eye corner blocks. The current owners have stripped and repainted or restained most the woodwork. Previous owners were responsible for the non-original round-arched openings between the hall and parlor and the parlor and dining room. The current owners installed the non-historic mantel and firebox surround in the northwest corner of the parlor. The second floor contains three bedrooms of varying sizes. Access to the unfinished attic is provided by an enclosed stair in the small southeast bedroom. Of the two upstairs bathrooms, only one is original and neither contains old fixtures.

The Holland-Brown house is a good example of the Foursquare, a nationally popular house form built in Riverdale and other Washington area suburbs throughout the early 20th century. The house is sited on the north side of Riverdale Road (originally Jefferson Street), about a block northwest of the Riversdale Mansion. Although the house is now aluminum sided, the house's massing and fenestration are still intact, making it a familiar visual feature of the streetscape along Riverdale Road.

The land on which Riverdale Park was built had been part of the Riversdale Plantation established in 1801 when Henri Joseph Stier, a Belgian aristocrat, purchased 800 acres north of Bladensburg and began to develop a plantation. After Stier's return to Belgium in 1803, completion of the Riversdale Mansion and management of the plantation were taken over by his daughter Rosalie and her husband, George Calvert. The Riversdale Plantation became a model of its type, and remained within the Calvert family for three generations.¹ After the death in 1864 of Charles Benedict Calvert (son of Rosalie and George Calvert), a commission was appointed to divide the plantation among his heirs and a 300-acre dower lot, including the mansion and the family burial ground to the northwest, was laid off for Calvert's widow.² This 300-acre dower lot (as well as the 175-acre lot adjoining it on the north) was sold by Calvert heirs in 1887 to John Fox, president of the Riverdale Park Company, a New York real estate syndicate which then began to develop the suburb of Riverdale Park.³

The land was platted in 1889 by surveyor D.J. Howell. Streets were laid out in a grid pattern, straddling the Washington line of the Baltimore & Ohio Railroad, which ran north and south through the new community and offered residents easy commuting into the Federal City to the southwest. Park spaces, and circles of green were provided in the plan and parkland was reserved around the Calvert mansion which was to be preserved "as a sacred relic of an era replete with historic memories."⁴ Streets were named for the Presidents of the United States, Washington through McKinley, as well as for other distinguished statesmen such as Clay, Lafayette and Beale.⁵

Construction of dwellings began in the early 1890s. All were of frame construction, and reflected the popular taste of the period, as illustrated in house plan catalogs of those years. Some were pyramidal-roof Foursquares, others front-gabled or cross-gabled; many were highlighted by projecting bays or corner towers, and almost all had prominent wraparound porches with jigsawed decorative details. By the turn of the century, the new suburb had approximately 60 dwellings, a Presbyterian church, a handsome Victorian schoolhouse and a railroad station; the latter two public buildings were built by the Riverdale Park Company. There were two general stores, and telephone and telegraph communications were available. Concrete sidewalks were constructed, and sewers were provided for the principal streets.⁶ Because of its convenient location, its efficient line of transportation into the City, its primary school, and its picturesque, tree-lined streets, Riverdale Park became one of the most desirable residential suburbs in the Washington area.

Assessment records indicate that the Holland-Brown House was built by Mamie E. and Christopher C. Holland sometime between mid 1909 and mid 1910.⁷ The Hollands had purchased lots 13 and 14 in Block 41 of Riverdale Park in June of 1909 and sold them in May of 1910 with a completed house on lot 14.⁸ The house changed hands a number of times after its sale by the Hollands. The longest term of occupancy began in 1943, when the house was purchased by Samuel T. Moore, Sr. The Moore family occupied 4716 Riverdale Road until 1978; until that time, lot 13 west of the house was retained as a sideyard.⁹ The one-car front-gable garage north of the house at the rear of the site was built by Moore in 1948.¹⁰

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The house at 4716 Riverdale Road is a two and a half story frame house which stands on one of the original lots of the 1890s subdivision of Riverdale Park. The house is square with a hip roof. There is one hipped dormer facing south and another facing west.

The covered entrance porch has a hipped roof and extends the full width of the house. The porch has an interrupted open railing with Tuscan columns. Originally there was a second-story porch above the present porch. There are three concrete steps leading to the entrance which were originally brick. The entrance is into the south facade which leads to a foyer in the southeast quadrant of the house.

The south facade is lighted by one, 2/2 window in the southwest quadrant, and a small window in the southeast quadrant. The second story is lighted by two, 1/1 symmetrical windows in the center of the facade.

The rear (north) of the house originally held a double-decker porch identical to the front, but has been enclosed and is now an interior room. It is also lighted by a 1/1 window. This porch has recently been extended to the east. The sides of the house (east and west) are lighted by five and four, 1/1 asymmetrical windows, respectively. There are no shutters on any of the windows.

The southern interior section of the first floor consists of two spaces, an entrance foyer and a sitting room in the southwest quadrant. There is a fireplace at a 3/4 angle in the northeast corner of this room. It has been rebuilt in the early 1900s style. There is an arched wall connecting the foyer with this room. There is a small decorative stain glass window on the east wall of the foyer, and one to the south. The floors are narrow board and the house originally had 2 X 4 wall planks which were uncovered during renovation.

The house is sheathed with grey shingles, and the roof has overhang eaves with no decoration. There is an interior chimney in the center of the roof with a corbelled cap. The

house rests on a concrete foundation which encloses a basement. There is the original cistern with two drain pipes in the basement. The foundation is partially covered with tin plates and lattice woodwork. The exterior of the house is covered by aluminum siding, which was placed over a brick exterior covering the original wood.

In the rear yard to the east is a detached car garage. It has a shingled gable roof and a brick facade from the roof to the sliding door. In the interior, the wood rafters are exposed. The sliding door is wide enough to accommodate one car. The original building permit from 1948 is displayed.

The house fronts Riverdale Road, originally Jefferson Avenue, and is one block to the northwest of the Calvert Mansion. There are small garden plots, a bush and a tree in front of the house.









South Elevation




