The building is a one story, log structure with a gable end entrance. The side elevation has one window. The logs have inverted V-notches; the gables are clapboard sheathed. On the southwest corner is an internal chimney. The west side wall has been sheathed with scallop-edged shingles; the other facades are exposed logs with the poles for chinking exposed.
