Description:

The Mallery House is a large frame structure, fronting on Beaver Heights Lane. The building consists of a high two-story gable roofed main block, roughly five bays wide across its main north facade. Entrance is in the fourth bay through a door with diamond headed vertical panes flanked by similar windows. Filling the second bay is a two-and-one-half-story semi-octagonal projecting bay, topped by an pyramidal roof, with crenellated cornice. The fifth bay is filled with two-and-one-half-story octagonal tower with pyramidal roof and plain board cornice. A one-story porch runs across the north facade of the building, its flat roof forming a second-story balcony. At the west corner of the building, this porch is enclosed and lighted by a bank of five modern double windows. The ground slopes steeply here and the basement has an entrance at grade level in the westmost corner. The entire building is covered with white asbestos shingle and rests on concrete foundations. Windows are generally 1/1, and have plain board surrounds; there are no shutters. The roof is covered with green asphalt shingle.

Significance:

The Mallery House at Beaver Heights was once a fine example of Shingle Style dwelling with Queen Anne style decorative elements. In recent years it has been enlarged and altered, and now serves as a day care center surrounded by playgrounds. Its shingle siding has been replaced, and it bears little resemblance to its original design. This house stands on parts of three lots in the Kenilworth subdivision, platted in 1895. Allen and Mary Mallery subdivided 10 acres of Kenilworth into Blocks 12 through 15; circa 1898 they had this dwelling constructed on lots 20-22 of Block 14. It was situated on a knoll just outside of the District of Columbia boundary, and was a fine example of Shingle Style dwelling, highlighted by a Queen-Anne-style crenellated bay and tower with curved roof. In 1927, the property became the subject of a suit in the Court of Equity, at which time it was described as being wooded and hilly, and having a beautiful ten-room house with 75 feet of porches and several outbuildings. It changed hands several times until it was purchased by the present owners who have undertaken significant additions and alterations. The resulting structure is large and somewhat fortress-like in appearance. Although the building is a prominent landmark, and its distinguishing features (the crenellated bay and the tower) survive, it has been altered to the extent that it is no longer representative of its style of construction.

The Mallery House at Beaver Heights is a large frame structure built on a slope so that part of it is two stories and part is three stories high. Its main facade is to the north, fronting on Beaver Heights Lane; to the south, the property slopes down to Cougar Lane and consists of a terraced playground. The building is presently used as a day-care center.

The building consists of a high two-story gable roofed main block, roughly five bays wide across its main north facade, with the second bay consisting of a projecting bay and the fifth consisting of a corner tower. Increasing the length of the building is an enclosed porch which wraps around the base of the tower on the west. Entrance is in the fourth bay through a door with diamond headed vertical panes flanked by similarly paned windows. Filling the second bay is a two-and-one-half-story semi-octagonal projecting bay, the three projecting faces filled with single or double 1/1 double-hung-sash windows. The projecting bay is topped by an octagonal pyramidal roof, with crenellated cornice. The fifth bay is filled with two-and-one-half-story octagonal tower (set into the northwest corner of the building) the faces of which are filled with 1/1 double hung sash windows. The tower has a octagonal pyramidal roof with plain board cornice, and no crenellation.

A one-story porch runs across the north facade of the building, it is supported by plain posts, and its flat roof forms a second-story balcony. A door in the north face of the corner tower opens onto this second story balcony. At the west corner of the building this one-story porch is enclosed and lighted by a bank of five modern double horizontal windows. The ground slopes steeply here and the enclosed porch has a basement with an entrance at grade level in the westmost corner. There is a metal fire escape at this west facade.

There are two large rectangular brick chimneys at the ridge of the main block, one at the east gable end, another between second and third bays. There are two rectangular hiproofed projecting bays on the south (rear) facade, at the southeast and southwest corners of the building.

The entire building is covered with white asbestos shingle and rests on concrete foundations. Windows are generally 1/1, and have plain board surrounds; there are no shutters. The roof is covered with green asphalt shingle. Old fieldstone gate posts mark the north boundary of the property.

The Mallery House at Beaver Heights was once a fine example of Shingle Style suburban dwelling with Queen Anne style decorative elements. In recent years it has been enlarged, by below-grade construction and enclosure of part of the porch. It now serves as a day care center surrounded by playgrounds, its shingle siding has been replaced, and it bears little resemblance to its original design.

This house stands on parts of three lots in the Kenilworth subdivision, which was platted in 1895 by the Mallerys out of the estate of James H. Fowler known as "Fife Enlarged". Allen and Mary Mallery subdivided 10 acres of Kenilworth into Blocks 12 through 15; circa 1898 they had this handsome and spacious shingle style dwelling constructed on lots 20-22 of Block 14. It was situated on a knoll just outside of the District of Columbia boundary on steep and gullied terrain. The house had ten rooms, 55 windows, porches on two sides, and was equipped for furnace heat. Complete with several small outbuildings, this house was assessed at the turn of the century at \$4000.<sup>1</sup>

The Mallerys had taken out a mortgage to cover the cost of the building, and lost it in 1917 through default in payment.<sup>2</sup> The property (lots 18 through 35) changed hands several times after that, and in 1927 became the subject of a suit in the Court of Equity. At this time, Harvey Akers sued for non-payment William Gardner to whom he claimed to have sold the property. In the course of the suit, the property was described as being wooded and hilly, and as having a beautiful ten-room home with 75 feet of porches, and outbuildings which included a chicken house and two-car garage. The house itself was a fine example of Shingle Style dwelling, highlighted by a Queen-Anne-style crenellated bay and tower with curved roof. Akers recovered the property, but sold it again within the year.<sup>3</sup> It changed hands four more times until the building and lots 18 through 23 were purchased by Laura and Odell Shumate, who have enclosed part of the porch and constructed several additions including the large basement-level


