Mt. Nebo Church is a one-story frame gable-roofed structure, built in several sections. The oldest section is three bays wide with entrance through a windowless tower (with pyramidal roof) built onto the south gable end; the tower is flanked by 2/2 double-sash windows. At the north gable end is a newer one-bay extension, onto which is attached an ell which turns to the west.

The present church was constructed in 1925 to replace the original church (1877). In June 1877, one acre out of William Plummer's "Poplar Ridge" tract was sold to three black trustees for the purpose of establishing an African Methodist Church and burial ground for colored persons. This one-acre lot adjoined the recently completed (1875) "colored" schoolhouse. Together the church and school became a focal point for the black community of Queen Anne on the Patuxent River, and remains so today.

Mt. Nebo Church is a one-story frame gable-roofed structure, built in several sections. The original section is three bays wide, with a tall brick chimney rising from the west slope of the roof between the second and third bays. Entrance is through a windowless tower (with pyramidal roof) built onto the south gable end; the tower is flanked by 2/2 double-sash windows.

At the north gable end is a newer addition, which extends the length of the building by one additional bay. To this has been attached a one-bay addition, which turns to the west, forming an ell.

The present church was constructed in 1925 to replace the original church which had been built soon after 1877. In June of 1877, one acre out of William Plummer's "Popular Ridge" tract was sold to three Negro trustees (Richard Wood, George W. Larkins and Wilson Turner) for the purpose of establishing an "African Methodist Church and burial ground for colored persons."¹ This one-acre lot adjoined the recently completed (1875) colored school house; together the church and school became a focal point for the black community in this area near the Patuxent River, between Mitchelville and Upper Marlboro.

Just north of the church is the burial ground, with many gravestones from the early years of this century.




