Description:

The Amelia Balser House is a two-and-one-half-story frame gable-roofed duplex house, ca. 32 by 28 feet. Its main south facade is four bays wide, with doors in the first and fourth bays. The opening in the first (west) bay has a heavy Victorian door with arched panels. Across this south main facade runs a one-story shed-roofed porch; there are two interior chimneys. The surrounds of the windows are plain board painted dark green and surmounted by a crown molding. At the east gable end there is a one-bay two-and-one-half-story half-gable (flounder) addition. Another three-bay-wide one-and-one-half-story half-gable (flounder) addition has been attached at right angles at the rear (northwest) of the house. There is a central doorway in its west facade, and a stove chimney between second and third bays on the west (only) slope of its roof. The entire house is covered with white asbestos shingle, windows are 2/2, the roof is of red standing-seam tin, and the foundations are of brick. The house fronts directly on Old Marlboro Pike.

Significance:

The Balser House is a rare surviving example of a nineteenth-century two-family town house. It was built shortly after 1881 by Amelia Balser on the site of the house in which her parents, the Charles Colemans, had previously lived. The 12-acre Coleman farm, which fronted on the Washington-Marlboro Road, was divided between Coleman's heirs, and during the latter years of the nineteenth century, the two-family house was shared by members of the Balser family. The two halves of the farm were rejoined and sold together in 1901 to William Gray, who in the next two years constructed the rear "flounder" kitchen wing, and excavated the basement under the main block. There have been three subsequent owners, and the two-family house has served as a dwelling for both owners and tenants. The house is unusual in the method of its expansion, i.e., the construction of flounder, or half-gable, additions, rare in Prince George's County. At the same time, it is a rare surviving example of a nineteenth-century duplex house.

The Amelia Balser House is a two-and-one-half-story frame gable-roofed duplex house, ca. 32 by 28 feet. Its main south facade is four bays wide, with doors in the first and fourth bays. The opening in the first (west) bay has a heavy Victorian door with arched panels. Across this south main facade runs a one-story shed-roofed porch supported by plain posts, square in section. There are two interior chimneys (not identical) between the first and second bays, and between the third and fourth bays. The surrounds of the windows are plain board painted dark green and surmounted by a crown molding.

At the east gable end there is a one-bay-wide two-and-one-half-story half-gable (flounder) addition; there is one window (both at first and second stories) on the south vertical face of this addition. Another three-bay-wide one-and-one-half story half-gable (flounder) addition has been attached at right angles at the rear (northwest) of the house. There is a central doorway in its west facade, and a stove chimney between second and third bays on the west (only) slope of its roof.

This building was constructed to house two families, the western half having been constructed earlier than the eastern; the exterior weatherboard of the western section is visible from the eastern section of the attic. Each of the living units consists of two rooms, front and back, on each floor, with a small enclosed staircase in the corner of the rear room. There is a basement under the front two rooms of the house, accessible only from a bulkhead opening at the west gable end; it was excavated early in this century for the installation of the furnace.

The entire house is covered with white asbestos shingle, windows are 2/2, the roof is of red standing-seam tin, and the foundations are of brick. The house fronts directly on Old Marlboro Pike.

The Balser House is a rare surviving example of a nineteenth-century two-family town house. It was built shortly after 1881 by Amelia Balser on the site (and probably on the foundations) of the house in which her parents, the Charles Colemans, had previously lived. Charles Coleman immigrated from Germany as a young man, and since 1859 had operated a 12-acre farm on the north side of the Washington-Marlboro Road, at the western edge of the town of Long Old Fields (known after the Civil War as Forestville).¹ In 1875, Coleman sold the western half of his farm to Conrad Balser, husband of his daughter, Amelia; the dividing line of the property ran through the center of Coleman's former dwelling. This two-family house was destroyed sometime between this time and Conrad Balser's death in 1881; shortly after that time, Balser's widow, Amelia, built a new six-room, two-family house, first the west section and then the east.² The eastern half of the farm (six acres) was subsequently sold to the Balsers' son, William; William Balser and his family lived in the eastern section of the house, while the western section of the house was occupied by Mrs. Balser and her mother, Margaret Coleman.

The two adjoining halves of the 12-acre farm were sold together in 1901 to William Gray, commander of a riverboat line from Pennsylvania, who in the next two years constructed the rear "flounder" kitchen wing, and excavated the basement under the main block.³ There have been three subsequent owners, and the two-family house has served as a dwelling for both owners and tenants.⁴

The house is unusual in the method of its expansion, i.e., the construction of flounder, or half-gable, additions, rare in Prince George's County. At the same time, it is a rare surviving example of a nineteenth-century duplex house.


