Description

The Terrett House is a two-and-one-half-story hip-roof frame house of the Colonial Revival style. It is foursquare in plan, and is distinguished by two-story verandas on two elevations and fine interior detail. The main block is three bays by three, with entrance in the central bay of the principal west facade. There is a similar entrance in the east facade. Each of the east and west facades is sheltered by a two-story flat-roof Tuscan veranda with jig-sawn balustrade. The siding is plain horizontal board painted white. Windows are generally 1/1 double hung sash with border lights on the upper sash. Six hip dormers pierce the hip roof of the building, two each on the north and south planes, and one each on the east and west planes. On the east elevation, the opening in the third bay is a large semi-circular window in eight sections; the curved upper sections are filled with patterned stained glass. Extending to the north, flush with the east elevation of the main block is a one-story hip-roof wing. It is two bays by two, and incorporates an originally freestanding carriage house which was moved from its location southeast of the house and relocated on a poured concrete foundation.

Significance

The Terrett House is a good example of an early twentieth century hip-roof foursquare or "Classic Box" dwelling. It also incorporates an unusual amount of late Victorian decorative detail, both exterior and interior, and is distinguished by two-story verandas across both the east and west elevations. The house was built circa 1908 by Alexander H. Terrett on "Bird Lawn Farm", part of the extensive landholding of Henry B. Bird. Terrett operated a dairy farm on the property, and built the subject house as his family home. After Terrett's death, his widow sold the farm; it passed through several owners until 1944 when it was purchased by Frederick Crawford, Congressman from Michigan. The Crawfords dismantled a Victorian house in Saginaw, Michigan, and incorporated some of its fine interior and exterior detail (stained glass, mantels, and verandas) into the renovation of the Terrett House. After Crawford's death, his widow sold the farm to developers who developed the Maplewood subdivision around the house. During the 1970's the owners moved the carriage house from its location southeast of the house, and attached it to the north side of the house as a family room wing. The Terrett House has seen substantial changes, but it still remains a visible example of a style of house which was popular in Prince George's County at the beginning of the twentieth century, and is a prominent landmark in a developed area.

The Terrett House is a two-and-one-half-story hip-roof frame house of the Colonial Revival style. It is foursquare in plan, with an added wing which incorporates an original carriage house; the house is distinguished by two-story verandas on two elevations and fine interior detail.

The main block is three bays by three, with entrance in the central bay of the principal west facade through a five-panelled door with four-light transom of stained patterned glass and five-light sidelights over molded panels. There is a similar entrance (without stained glass) centered in the east facade. Each is enframed with a plain board surround. Each of the east and west facades is sheltered by a two-story flat-roof veranda supported by six slim Tuscan columns. The second story of the veranda is bounded by a jig-sawn balustrade of open-work pattern; there is a dentilled freeze below this balustrade on the principal west facade. Entrance from the second story onto the balcony is by a double door with upper glazing, centered on each of the east and west elevations.

The siding is plain horizontal board painted white. Windows are generally 1/1 double hung sash with border lights on the upper sash. They have plain board surrounds with a molded lintel, and black louvered wood shutters. The hip roof is covered with black asbestos shingle. The cornice is boxed, with a plain board frieze, all painted white. Six hip dormers pierce the hip roof of the building, two each on the north and south planes, and one each on the east and west planes. The east and west dormers each enclose two side-by-side 2/2 double hung sash windows framed by molded pilasters. On the north and south, each dormer has a molded cornice and contains a single 2/2 double hung sash window.

There are two brick chimneys, one interior chimney rises from the south plane of the roof between the two dormers, and there is an exterior chimney at the north elevation, between the two dormers. The house rests on a poured concrete foundation.

On the east elevation, the opening in the third bay (north of the central entrance) is a large semi-circular window in eight sections. Its lower central light consists of a large picture-window pane, flanked by two smaller double hung sashes; the three small curved upper sections are filled with patterned stained glass.

A small one-story hip-roof addition has been built onto the south elevation to enlarge the kitchen space in the southeast quadrant of the main block.

Interior plan of the main block consists of a stairhall in the central west space, a small library in the southwest space, and a large living room which takes the entire north third of the house. The living room turns to the east to form an ell, and one enters the dining room in the ell through a wide molded arch. An ornate and very wide wood mantel frames the fireplace in the north wall of the living room. It has wide fluted and tapered pilasters, and a molded frieze; ornamental tiles frame the firebox and the wood mantel itself is painted white.

Extending to the north, flush with the east elevation of the main block is a one-story hip-roof wing. It is two bays by two, and incorporates an originally freestanding carriage house which was moved from its location southeast of the house and relocated on a poured concrete foundation. Siding and roof cover of the wing are the same as the main block; there is a small hip-roof cupola centered at the ridge. Windows are generally small 1/1, but there are two large 16-pane windows side-by-side in the south bay of the east elevation. Interior space in the carriage house wing consists of one large room; a window in the eastmost bay of the north wall of the main block was extended to form a doorway into the carriage house wing.

The house stands on a large lot on the north side of Stonesboro Road. The grounds to the east of the house consist of gardens. There is a small hip-roof metal shed at the north end of this garden space. Several large hollies frame the west grounds of the house.

The Terrett House is a good example of an early twentieth century hip-roof foursquare or "Classic Box" dwelling. It also incorporates an unusual amount of late Victorian decorative detail, both exterior and interior, and is distinguished by two-story verandas across both the east and west elevations.

The house was built circa 1908 by Alexander H. Terrett on "Bird Lawn Farm", a 260-acre farm in the Surratts District of Prince George's County. This farm was part of the extensive landholding of Henry B. Bird, after whom the farm was named.<sup>1</sup>

Henry B. Bird of Delaware had purchased over 600 acres of land before the Civil War, and operated a large farm until the beginning of this century. In 1907 he sold Bird Lawn, (331 acres) to Alexander H. Terrett, who continued to operate a dairy farm on the property.<sup>2</sup> Terrett built the subject house as his family home. A brick foundation discovered just a few feet from the house suggests that it was built very close to the original Bird dwelling. The new house was typical of the substantial frame houses of the first decade of this century, square, with hip-roof pierced by hip dormers. Recent roof work suggests that the original roof cover was slate.<sup>3</sup> The Bird Lawn Farm had a complex of outbuildings, including dairy barns and silos; near the house was a carriage house, and several other small sheds.<sup>4</sup>

After the death of Alexander Terrett, his widow sold the farm, and it passed through several owners until the southerly 261 acres, bounding on Steed Road, were purchased by Frederick and Elizabeth Crawford. Frederick Crawford (1888-1957) had been elected as Congressman from Michigan to the 74th U.S. Congress in 1934, and was re-elected to eight subsequent terms. In 1944, he purchased the southerly part of Bird Lawn Farm and continued to operate a dairy farm there during his years in Congress.<sup>5</sup> Soon after the Crawfords purchased Bird Lawn Farm, they dismantled a victorian house in Saginaw, Michigan, and incorporated some of its fine interior and

exterior detail into the renovation of the Terrett House. This included the stained glass in the west transom, the fine semi-circular window in the east elevation, the living room mantel, and the two-story verandas with their Tuscan columns and jig-sawn balustrade. (At the same time the Crawfords built a small addition on the south which enlarged the kitchen space.) The handsome Foursquare became a prominent landmark.

Frederick Crawford retired from Congress in 1953, and died four years later. In 1964 his widow sold the entire farm to developers who subdivided the property for residential development. Two large lots were retained as the grounds for the dwelling and carriage house, and the Maplewood subdivision was built around them.<sup>6</sup>

The house and two lots were purchased in 1975 by Ronald and Sheila Crane, who moved the carriage house from its location southeast of the house, and attached it to the north side of the house as a family room wing. The result is an effective addition of living space, and a wing which reflects the lines of the house itself.

The Terrett House has seen substantial changes, with the incorporation of Victorian decorative detail from a Michigan building, and the conversion of a carriage house into a wing addition. It still remains a visible example of a style of house which was popular in Prince George's County at the beginning of the twentieth century, and is a prominent landmark in a developed area.

The Terrett house is a frame two-story house with hipped roof. The (main) west facade is three bays wide. The central entrance has transom and sidelights, and is flanked by two double windows. The upper sashes of the first story windows are bordered by small square colored lights. The west and east facades are spanned by two-story hexastyle porches: the first story porch has a dentiled cornice, and the second has an intricately cut balustrade. There is a dormer window over the central west entrance.

This house, built by the Terrett family circa 1910, stands on the location of Henry B. Bird's nineteenth century farmhouse on the plantation known as Bird Lawn. (Bird had owned the farm for over 50 years when he sold it in 1907 to Alexander Terrett.) This is a large old farmhouse, that sits in the recently built Oaklawn Subdivision. The house is a large, square, two-story frame block that faces west. It has a steep hip roof, with dormers on each slope. A two-story porch spans the front. The second story rail is a Victorian "jig-saw" balustrade and beneath this, the first story cornice features a dentil row. The central door has transom and side-lights. The door is flanked by slim, double windows. There is a small wing attached to the north side. The house may possibly contain elements of an earlier structure, as there is a huge magnolia tree growing in the front yard.




