Description:

The Marlboro Hunt Club is a long two-story, nine-by-three bay gable roof frame structure with a side gable entrance. The building was completed in stages, starting with a three-bay central core constructed ca. 1856. A three bay west addition was made in the 1880's, doubling the size of the structure. A four bay south addition was made in the 1920's. Two north bays were added in the 1930's. The building fronts on the Patuxent River with a view of Hill's Bridge, the Route 4 crossing over the Patuxent. The surrounding 20.8 acre property is a mix of open fields and wooded areas.

Significance:

The Marlboro Hunt Club is significant as a special purpose building. Since the 1880's it has housed a sportman's club. As the Patuxent Gun and Rod Club in the late 19th and early 20th century it was visited by such guests as Theodore Roosevelt and Franklin Delano Roosevelt. The building is architecturally significant for interior and exterior details surviving from its three early stages of construction. The core building dates to the mid-19th century, with an addition doubling its size in the 1880's. The south four bays and north two bays were added to the building in the 1920's and 30's. A large one story rear addition was constructed in 1978.

The Marlboro Hunt Club is a long two-story, nine-by-three bay gable roof frame structure with a side gable entrance. The building was completed in stages, starting with a three-bay central core constructed ca. 1856. A three bay west addition was made in the 1880's, doubling the size of the structure. A four bay south addition was made in the 1920's. Two north bays were added in the 1930's. The building fronts on the Patuxent River with a view of Hill's Bridge, the Route 4 crossing over the Patuxent. The surrounding 20.8 acre property is a mix of open fields and wooded areas.

The nine bay east (main) facade has entrances in the third, fourth and seventh bays. All are glazed, with fifteen lights and are surmounted by a three-light transom. Windows on the facade are six-over-six wooden double-hung-sash. The fourth through the eighth bay is sheltered by a four bay, flat roof one story porch. Decorative cut rafter ends project beneath the overhanging eaves. The porch roof rests on chamfered wood posts. The wooden floor rests on low cement blocks.

The Hunt Club is covered with white-painted board-and-batten siding, the battens providing surrounds for the doors and windows. Two interior chimneys rise from the east and west roof slopes, between the fourth and fifth bays. The new roof is of a rust-colored synthetic shingle. There are deeply overhanging eaves over decoratively cut rafter ends. The building rests on a low brick foundation. Unevenness in the roof ridge can be attributed to the several additions. The north two bays of the main facade rest on a cement foundation, and there is a cellar beneath this ca. 1930's addition.

The two bay north gable end has a wide exterior parged chimney to the west of the gable ridge. An entrance in the first bay is identical in detail to those on the main facade. A facade-wide porch identical to that on the main facade shelters the first story. There is a central four-over-four second story window, flanked by two small square four-light windows. A rectangular opening without glass is centered in the upper gable.

The west (rear) facade is approximately six bays on the main block, with one entrance through an old four-panel door in the second bay. The west facade is dominated by a large one-story frame addition dating to 1978, of four-by-three bays with a gable roof. The addition houses one large room. It is set on a cement base and has board-and-batten siding. It is roofed with the same material as the main block. There is a central west entrance into the addition, through double doors. A shed roof projecting bay at the southwest corner of the addition was the old summer

kitchen for the property. The summer kitchen was incorporated into the new addition's structure.

The interior of the Hunt Club has a complex plan. It began as a side hall, one parlor structure. The second entrance into the main facade is the original entry. In the 1880's the hall was extended to the west (rear) and a second, west parlor was added, giving the building a north side hall and two south parlors. The stair, with plain rectangular balusters and newell, probably dates from this time, as it rises from the west (rear) of the stair hall.

The two south parlors are warmed by hearths with identical mantels in the south wall of each room. The mantels have flat pilasters on base blocks flanking the square hearth opening. In the east parlor the frieze below the mantel shelf has an inscription formed by the ends of embedded shotgun shells, reading "18 P.C. 89". The west mantel frieze has only the initials "P.C.". The dividing wall between the parlors was removed in recent years, creating one large room with two south hearths. There are two doors in the south wall, between the hearths. The east door leads to the dining room, the west door leads to the southwest parlor. The door has the name "Florence" across its upper half, of embedded shotgun shells.

The walls in the stair hall and parlors are covered with wide vertical boards with beveled edges, painted white. There is a pedestal chair rail in the stair hall. The wooden flooring is original. The building was expanded to the south in the 1920's by the addition of four south rooms. The woutheast room is a formal dining room, with a hearth and built-in paneled cupboards in the north wall. The wooden mantel has a Tudor-arch opening flanked by flat pilasters and surmounted by a plain frieze and mantel. The wainscotted over-mantel hs a large central panel covered with a section of antique wallpaper. The adjoining cupboard has round-arch upper glass panes in the panelled doors. The wall surface is divided by a chair rail, having plaster below and the painted wallpaper above. The wallpaper covers all walls of the room as well as the panel above the mantel. Called Chasse a Courre, it depicts a theme of horse racing, and dates to the 1830's.

The southwest room, added at the same time as the dining room, was remodeled in the 1920's with a large corbelled brick fireplace and wood paneling covering the walls. The southmost two rooms are a kitchen on the west and a utility room on the east. The northmost room, north of the stair hall was added in 1932.

The second story of the Hunt Club is in deteriorated condition, but is in the process of renovation. It has a long central hallway with many small rooms opening off each side. There are old board-and-batten doors and four-panel doors with decorative Victorian butt-hinges and one-step architrave surrounds. No hearths are apparent except in the two center rooms through who's walls the two chimneys from the south parlors pass. These hearths have been blocked off.

The Marlboro Hunt Club is significant as a special purpose building. Since the 1880's it has housed a sportman's club. As the Patuxent Gun and Rod Club in the late 19th and early 20th century it was visited by such guests as Theodore Roosevelt and Franklin Delano Roosevelt. The building is architecturally significant for interior and exterior details surviving from its three early stages of construction. The core building dates to the mid-19th century, with an addition doubling its size in the 1880's. The south four bays and north two bays were added to the building in the 1920's and 30's. A large one story rear addition was constructed in 1978.

The Hunt Club is located on a tract called Green Landing Farm, originally a part of Billingsley. 1/ Sited close to the Patuxent River, it was part of a grouping of buildings which formed Hill's Landing, a fishing landing and dock for steamboats during the 19th century. The 1861 Martenet's Map of Prince George's County and the 1878 Hopkins Atlas depict a cluster of buildings including a store at the landing.

The core of the Hunt Club structure, composed of a north hall and south parlor, was probably constructed around the time that the landing was acquired by William B. Hill, in 1856. 2/ The building was enlarged in the 1880's by the addition of extra length to the west in the stair hall, a stairway and a southwest parlor. The Patuxent Gun and Rod Club was using the building by 1889, and it is probable that that organization completed the renovations. 3/ Dating from the 1880's are the parlor mantels, the flooring, the stair, and the four-panel doors with Victorian engraved hinges and architrave door surrounds on the second story.

The Patuxent Gun and Rod Club was formed by members of the Metropolitan Club of Washington, D.C., interested in bird hunting and fishing along the Patuxent. Membership was exclusive, as members had to be nominated by the Metropolitan Club. 4/ Features in the building that attest to its long use as a club include the many small, unheated sleeping rooms which open off the central hall on the second story. A bank of small wooden cabinets formerly located in the southwest parlor but now in the large, ca. 1978 club room are numbered and locked. Still in use, they served as lockers, probably for alcoholic beverages, for club members. The guest register is signed some well-known public figures, including Theodore Roosevelt, 1919, and Franklin D.

Roosevelt, 1917. The date "1889" and the initials "P.C." for Patuxent Club, composed of shotgun shells, are embedded in the parlor mantels. The southwest exit from the parlor leads to the kitchen. The name "Florence", spelled across the door in shotgun shells, refers to a cook who served the club in the 1910's and 1920's. 5/

A ca. 1910 photograph of the club building depicts a two story building with a side gable entrance, a north door and two south bays. The decoratively cut rafter ends on the porch and cornice were present at that time, and have continued as a feature as the building has expanded.

Four rooms were added to the building ca. 1925, including an east dining room and west parlor adjoining the south parlors already described. A kitchen and utility room were added at the south end of the building. 6/ A room north of the stair hall, at the north end of the building was added in 1932.

The dining room was constructed to display the sheets of scenic, antique wallpaper in the possession of the club. Called "Chasse a Courre," the paper depicts hunting scenes, in bright color. Printed ca. 1830 in Paris by Joseph Du Four 7/, it was probably donated to the building by a club member. It originally hung in the stair hall and was moved in 1925 to the dining room. 8/

The club building and surrounding 20.8 acres was sold to the Marlboro Hunt Club in 1950. 9/ The club continues to use the building and is in the process of renovating the second story.

The Marlboro Hunt Club is a long two story building with board and batten siding, with its main facade facing east toward the Patuxent River. The central (oldest) section was three bays wide with two exterior chimneys at the south end. The entrance, in the third (northmost) bay of this oldest section, leads into a hall; the two parlors to the south may be entered from this hall. In 1925, a four bay addition was built on the south end of the building, thus enclosing the two end chimneys; the "Chasse a' Courre" scenic wallpaper which hung formerly in the hallway was rehung in the new dining room, especially designed for this purpose. In 1932, a two bay parlor was constructed north of the original hall; these two twentieth century additions have more than doubled the size of the original structure. Very recently, a large one story ball room addition has been constructed on the west.

This structure stands on "Green Landing", which was purchased by William B. Hill in 1855. The house was built at approximately this time and stood in a cluster of buildings at this busy fishing and steamboat landing. The scenic wallpaper, although it was made in Paris circa 1830, was probably hung in the hallway in the late 1880's when the building first began to be used as a hunt club. William B. Hill died in 1890, devising the Green Landing to his daughter, who sold it to the Patuxent Gun Club in 1908. It became the Marlboro Hunt Club in 1950.

STATEMENT OF SIGNIFICANCE

This structure stands on "Green Landing", which was purchased by William B. Hill in 1855.¹ The house was built at approximately this time, and stood in a cluster of buildings at this busy fishing and steamboat landing. The scenic wallpaper, made in Paris circa 1830,² was probably not hung in the hallway until the late 1880's when the building first began to be used as a hunt club. William B. Hill died in 1890, devising the Green Landing to his daughter, who sold it to the Patuxent Gun Club in 1908.³ It became the Marlboro Hunt Club in 1950.






