Description:

The John N. Walls House was previously surveyed by the Prince George's County Historic Preservation Commission in September 1985. Since the time of the previous survey there have been no changes to the house or outbuildings.

National Register Evaluation:

The John N. Walls Property, previously surveyed by the Prince George's County Historic Preservation Commission in September 1985, is not eligible for the National Register of Historic Places. The property is not eligible under Criterion A, as research conducted indicates no association with any historic events or trends significant in the development of national, state or local history. Historic research indicates that the property has no association with persons who have made specific contributions to history, and therefore, it does not meet Criterion B. It is not eligible under Criterion C. The house has been altered and expanded to such an extent that much of its historic character has been changed. The enclosing of the front porch and the construction of additions have changed the form and massing of the original structure and have also introduced architectural elements out of character with the original design intent. Finally, based upon the date of construction and the property type, there is a likelihood that an archaeological component could exist on the property. However, as no archaeological investigation has been conducted, the eligibility of the property under Criterion D cannot be assessed at this time.





Description

The F. A. Rowe House is a multi-part frame house set on a small rise above McKendree Road. It consists of a two-story cross-gabled structure in the shape of an L, to which another gable-roof section has been added at right angles, making the configuration of a squared C. The main block is an irregular five bays by one bay, with entrance in the central bay of the five-bay south facade. Across the south facade is a one-story shed-roof porch, which is fully enclosed to form a sunroom. At the east gable end is an exterior block-and-brick chimney, which replaces an original interior chimney; it is stuccoed and painted white. The German wood siding of the house is covered with grained white vinyl siding; windows are 6/6 double hung sash, with plain wide vinyl surrounds and green louvered vinyl shutters. There is a two-story rear ell wing, three bays by two, at right angles to the main block, its west facade flush with the west gable end of the main block. Attached to the east facade of the ell, and running east is a second two-story gable-roof wing. Material and fenestration of the wings are the same as those of the main block. The house stands on landscaped grounds, with a garage, bake oven, small barn and small tenant house within the larger 50-acre property.

Significance

The F. A. Rowe House is a multi-part house which has been expanded in an unusual way from a small nineteenth-century dwelling into a complex building. The original house was probably the easterly 3/5 of the main block. It is possible that this section was the home of John T. Boswell, who lived on this 273-acre tract in the 1840s. The property passed to Boswell's daughter and her husband John N. Walls, but in 1859 suit was brought against Walls and the farm was sold. The new owner was F. A. Rowe, a schoolteacher-turned-farmer whose family resided on the property until the end of the century. It was the home of Mary Baden's family during the early twentieth century, by then considerably enlarged with a rear ell wing, and later the north wing added to the ell. In 1941 the house and 160 acres were sold to Marco DeCesaris, and it was he who rebuilt the east chimney and who enclosed the south porch. Since 1951 the property has been the residence of the Kissinger family who have maintained the house in its enlarged and modernized condition. The house is a noticeable landmark, but it has been renovated over time to the extent that its historic character is no longer recognizable.

Description

The F. A. Rowe House is a multi-part frame house set on a small rise above McKendree Road. It consists of a two-story cross-gabled structure in the shape of an L, to which another gable-roof section has been added at right angles, making the configuration of a squared C.

The side-gabled main block is an irregular five bays by one bay, with entrance in the central bay of the five-bay south facade. Across the south facade is a one-story shed-roof porch that is fully enclosed; this enclosed porch has four pairs of 6/6 double-hung-sash windows, with a door in the center. At the east gable end is an exterior brick-and-block chimney, with weatherings at second-story level. The chimney (which replaces an original interior chimney) is stuccoed and painted white. The German wood siding of the main block is covered with grained white vinyl siding, as are the walls of the enclosed south porch. Windows are 6/6 double-hung-sash, with plain wide vinyl surrounds, and green louvered vinyl shutters. The roof is covered with green asphalt shingle and has a deep overhang at the eaves. There is no decorative cornice. Foundations appear to be concrete block; there is no basement beneath the main block.

Interior of the main block exhibits many early-to-mid-twentieth-century decorative features, such as the interior doors and moldings, and in particular the main staircase, which rises along the east wall of the main west parlor. The enclosed south porch has been converted into a sunroom on the west, and an extension of the parlor/living room to the east of the entrance.

There is a two-story rear ell wing, with the ridge of its gable roof at right angles to that of the main block, and its west facade flush with the west gable end of the main block. The materials and fenestration of this wing are the same as those of the main block; there is, however, a basement space under the ell. The foundations appear to be brick, reinforced with concrete block. The ell is three bays long and its north gable end is two bays wide. On the west facade of this ell wing is a one-story hip-roof enclosed porch, with entrance in the third bay of its four-bay width.

Attached to the east elevation of the ell wing, and running east is a second two-story gable-roof wing, parallel with the main block. Its east gable end is one bay wide, and it adds an additional two bays to the length of the north elevation. There is an interior corbelled brick chimney at its ridge. Partially filling the space inside the C configuration, and attached to the north elevation of the main block, is a one-story concrete-block enclosed porch; it is sheathed as is the rest of the building with white grained vinyl siding.

A paved driveway leads from McKendree Road to a wider paved area west of the house. Immediately west of this paved area is a four-bay side-gabled garage, dating from the 1940s. It is sheathed with white grained vinyl siding, with green corrugated metal roof.

A short distance north of the house is a small front-gabled barn, with plain horizontal board siding painted white; a sliding window, with two six-pane sashes, lights the loft level on the south. There is a shed-roof porch on each of the south and north ends; the main entrance is on the south, while on the north there are two garage doors. The gable roof is covered with green corrugated metal. Between the house and this small barn is a concrete-capped well.

To the west of the small barn, on the same property but fronting on McKendree Road northwest of the principal driveway, is a small frame tenant house. It is side-gabled and one-story high, covered with stucco painted white; a shed-roof screened porch projects from the rear of this small cottage. At a distance in the wooded area to the north is a deteriorating gambrel-roof tobacco barn, within the circa 50-acre parcel of land, but not visible from the main house in summer months.

East of the main house, on a line with the northeast wing, is a small brick bake oven with two oven openings in its west face. This oven has a domed roof and a tall corbelled brick stack centered in its east (rear) wall.

The grounds of the F.A. Rowe house are carefully landscaped, with mature magnolia, holly and several pine trees in the front, and chestnut, dogwood, cherry, and more pine trees to the rear. Adjacent to this property on the east, a row of three small mid-twentieth-century side-gabled cottages stretches along McKendree Road in this still rural area. To the south, across the road from the Rowe House, is a farm with paddock, barns and riding ring.

Significance

The F. A. Rowe House is a multi-section house that has been expanded in an unusual way from a small nineteenth-century dwelling into a complex building. It has been modernized to the extent that its historic character is no longer recognizable, but it is a noticeable landmark on the old road from Charles County to the site of McKendree Church.

The original house was probably the easterly 3/5 of the main block, i.e., the east parlor and stairhall. This parlor was warmed by an interior chimney at the ridge, later dismantled and replaced by the modern exterior chimney. It is possible that this section was the home of John T. Boswell, who lived on this 272-acre tract in the 1840s;¹ the house has been so renovated, however, that it is impossible without destructive investigation to determine whether any of the original fabric may date from that early period. The property passed to Joanna, daughter of John T. Boswell, and her husband John N. Walls. In 1859, however, suit was brought against Walls in the Court of Equity, and the 272-acre farm was sold.² The new owner was F. A. Rowe, a schoolteacher-turned-farmer who had come to the area from Charles County in 1856. The Rowe family made this their home until the end of the century.³

For the first third of the twentieth century, this was the home of Mary C. Baden and her family. By now the house was considerably enlarged, with a rear cross-gable ell, and later the north wing at right

angles to the ell. In 1941 the house and 160 acres were sold to Marco DeCesaris, whose business was in building supplies.⁴ It was he, reportedly, who dismantled and rebuilt (on the exterior) the east chimney of the main block, and who enclosed the south porch, thus creating an additional sitting room. The DeCesaris family also built the bake oven (still standing) just east of the house, where they baked the family bread. They also constructed a small cinder-block manufactory (no longer standing) near the small front-gabled barn.⁵ Many of the interior renovations were done during the DeCesaris family ownership.

After the death of Marco DeCesaris, a fifty-acre portion of the DeCesaris property, including the house and grounds, was sold to Frederick and Kathryn Kissinger. The Kissingers built the garage and planted many of the now mature trees on the immediate grounds of the house.⁶ Over nearly fifty years of the Kissinger family residence, the house remains in the same configuration in which they purchased it. They have added synthetic siding, and have have maintained the house in excellent condition.

Today, most of the original Rowe family farmland has been sold, and a row of small mid-twentieth-century houses stretches to the east along McKendree Road. The Rowe House stands on a 50-acre parcel, in a prominent position above the old road from Charles County. The house has been expanded and modernized to the extent that its historic character is no longer recognizable, but it is a noticeable landmark in this still rural area.

The F.A. Rowe house is a multi-section house which has been expanded in an unusual way from a small nineteenth century dwelling into a complex building. It has been modernized to the extent that its historic character is no longer recognizable, but it is a noticeable landmark on the old road from Charles County to the site of McKendree Church.

The original house was probably the easterly 3/5 of the main block, i.e. the east parlor and stairhall; the parlor was warmed by an interior chimney at the ridge (later dismantled and replaced by the modern exterior chimney). It is possible that this section was the home of John T. Boswell, who lived on this 273-acre tract in the 1840's¹; the house has been so renovated, however, that it is impossible without destructive investigation to determine whether any of the original fabric may date from that early period. The property passed to Joanna Boswell, daughter of John T., and her husband John N. Walls, but in 1859 suit was brought against Walls in the court of Equity, and the 273-acre farm was sold.² The new owner was F.A. Rowe, a schoolteacher turned farmer who had come to the area from Charles County in 1856. The Rowe family made this their home until the end of the century.³

For the first third of the twentieth century, this house was the home of Mary C. Baden and her family. By now the house was considerably enlarged, with a rear cross-gable wing, and later the north wing at right angles to the ell. In 1941 the house and 160 acres were sold to Marco DeCesaris, whose business was in building supplies. It was he, reportedly, who dismantled and rebuilt (on the exterior) the east chimney of the main block, and who enclosed the south porch, thus creating an additional sitting room.⁴ Today, most of the Rowe's farmland has been sold, and a row of small modern houses stretches to the east along the road in this still very rural area. The house stands on a 50-acre parcel, in a prominent position above the old road from Charles County.




