DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is an abandoned, ruinous old farmhouse, that was built in two parts. The oldest part is a low, one-story building of hewn framing, covered with rough, wide-pine weatherboards. A brick fireplace chimney sits on the outside south wall. Attached to this part, on the north wall, is a later, two-story frame wing of very plain construction. It has sawn framing and lath, and a stove-chimney inside the north end-wall.






PATUXENT RIVER PARK
