The extant two-story frame farmhouse was built in 1909 for Herschel V. Maddox on the 18th-century site of the Daniel Ballard's old house, which was described in 1798 as,

1 dwelling house built of brick 42 feet
by 20 feet one storey high 2 windows
3½ feet by 3 feet 2 dormant windows

Also mentioned in the tax assessment were several old buildings as well as an unusual array of brick outbuildings which included a 20 foot square brick kitchen, a 12 foot square brick cyder house and a 12 foot by 12 foot smoke house. Not included in the assessment was the extant gable-front frame tobacco barn, evidently erected a few years after the assessment. Today, this barn is the most significant architectural aspect of this farm since it is one of three tobacco houses standing on Maryland's Lower Eastern Shore. The relatively few number of tobacco houses from this period is tied to the substantial decline in tobacco growing during the first quarter of the 19th century.

The Daniel Ballard Farm (also known as the Baner Layfield Farm) is situated on the north side of Maryland 361 between Manokin and Upper Fairmount, Maryland. The dirt lane to the farm complex intersects Hood Road immediately south of "Sudler's Conclusion" (S-56). The earlier lane, however, entered directly from MD 361 as indicated on the 1877 Atlas Map.

The farmhouse is a 1909 two-story, four-bay by two-room weatherboarded frame structure with steeply pitched asphalt shingle roof and stretcher bond brick foundation. According to Fred Willard, the present owner, the house was built on the site of the 18th-century dwelling.

The south (main) facade is divided into four bays with a door and window to either side of a centrally located chimney.

The most significant building on the property is a wrought-nail gable-front frame tobacco house, built c. 1800-1815. A steeply pitched corrugated tin roof covers the main barn as well as contemporary side sheds. The principal posts and braces are of mortise and tenon frame construction, but some interior siding and intermediate studs are fastened with wrought-nails. The eave construction is also significant since the tie beams support a plate. *SLIGHTLY CANTED FALSE STAPLE LINDING NAILS DROP THROUGH THE PLATE THREE TIERS OF COLLARS R* have half-dovetailed lap joints into each rafter pair. Corresponding to each *A THE PLATE AND APPROX* level of collar beam are the remnants of riven strips applied to the wall surface for hanging tobacco. Portions of these strips are also found within the main body of the barn. The barn exterior is sided with a combination of beaded and plain weatherboards. The west elevation has a center door opening, as well as a wagon bay opening to the left (north). A small window opening is located to the right (south). Patches in the exterior weatherboarding, in addition to interior structural evidence, indicates there were single door openings on the floors above.

An adjacent outbuilding is a mid 19th-century frame corn crib/wagon house. This bi-level frame structure is covered by a medium pitched tin roof and is sheathed with vertical board siding.

A single pen frame corn crib also stands on the farm and closer to the Ballard family cemetery. The cemetery includes close to one-dozen grave markers.

Standing in the woods behind the house is a single-story frame dairy, which was moved from the area around the barn. This badly deteriorated structure has a beaded internal frame and is sheathed with wide beaded weatherboarding. The eaves are wider than normal and the indication of louvered wall openings suggest the building function^{ed} as a dairy. Wrought nails were used originally, but the interior has been covered with narrow beaded boards.

Prepare both a summary paragraph of significance and a general statement of history and support.

The Daniel Ballard Farm is architecturally significant for the survival of a c. 1800-1815 wrought-nail frame tobacco house, one of three known to survive in Somerset County at this time. These three wrought-nail barns all date to the turn-of-the-19th century and represent the last generation of tobacco houses built on the lower Eastern Shore of Maryland. The three barns share construction features, which include tilted-false-plates, as well as an identical system for hanging tobacco. However, this system differs from that which is found on the Western Shore of Maryland.

History and Support

In 1798 Daniel Ballard (1763-1847) was assessed for his farm on Back Creek, which contained,

1 dwelling house built of brick 42 feet by 20 feet one storey high 2 windows 3½ feet by 3 feet 2 dormant windows 1 kitchen 20 feet square of brick 1 cyder house 12 feet by 12 feet of brick 1 smoake house 12 feet square of brick 1 milk house 12 feet square.....

The lands assessment recorded the 136½-acre tract of "Security" as well as,

1 old barn 20 feet square 1 old corn house 20 feet by 6'8" 1 old negro house 16 feet square

From this decription it is evident that the extant buildings, except possibly the milk house, post-date the 1798 federal assessment. The barn was apparently built within the next decade for Daniel Ballard's tobacco crop. In 1847 Daniel Ballard died and the fifth item in his will states,

*I bequeath unto my son Daniel James Ballard my farm on Back Creek whereon I now reside.

Daniel J. Ballard (1808-1891) remained on his father's farm throughout the next fifty years. In 1877 he was listed on the county's Atlas Patron list as a farmer with 180 acres.

Significance

In Daniel J. Ballard's 1891 Will he devised the "Homeplace where I now reside* and the residue of my land go to my son Daniel J. Ballard after the death of his mother." The old Ballard Farm remained in relatives hands until it was sold to Phillip O. Layfield in 1917. The present owners acquired the property in 1966.




